Educational and other qualification required:

Essential: BE (Civil)/ MA (Geography)/B.Arch./Bachelor of Planning and M.Sc. in GIS / M.Tech. with minimum 55% marks with 7 years experience in planning, execution and monitoring of projects. The candidates having specialisation in Disaster Management and working knowledge of GIS software will be given preference.

Preferential: candidate with specialization in remote sensing and Geographic Information System (GIS) will be given preference.

In case of Recruitment by Deputation to be made:

Officers under Central Govt. or State Govts. or Union Territory Govts. or Public Sector Undertakings or semi-Govt. or autonomous or statutory organizations:-
