No. K-14011/13/85-NCRPB—In exercise of the powers conferred by Section 32 of the National Capital Region Planning Board Act, 1985 (2 of 1985) National Capital Region Planning Board hereby further amends Notification No. K-14011/13/85-NCRPB dated 10-8-1985 whereby financial powers were delegated to the Member Secretary of the Board under Section 22(2)(a) under item III serial No. 6, 22 and 26, by virtue of his being Head of the Department under various Rules. The above said notification has been amended from time to time in the exigencies of the situation by Notifications 14-12-1987 and 4th July, 1991 leading to this amendment for enhancing the financial powers of the Member Secretary, which have been approved in the meeting dated 19-8-1996 of the National Capital Region Planning Board.

These shall be deemed to have come into force with effect from the date of their approval by the Board i.e. 19-8-1996.
