## AGENDA ITEM NO.3: DRAFT MASTER PLAN FOR GREATER NOIDA - 2021

The Draft Master Plan for Greater Noida 2021 prepared by the Greater Noida Authority was received in the NCR Planning Board on 28.8.2006. After examination the draft Master Plan for Greater Noida 2021 was placed before the 54<sup>th</sup> Planning Committee meeting held on 4.9.2006. The Planning Committee after consideration made several observations/suggestions to improve the Plan. Minutes of the meeting are at Annexure 3/I.

- Board received the replies on the observations/suggestions of the Planning 2. Committee from Greater Noida Development Authority vide their letter dated 02.02.2007. Board vide letter dated 9.5.2007 requested the GNIDA to incorporate the suggestions in the draft Greater Noida Master Plan and send the revised Master Plan for consideration of the Planning Committee. Greater Noida Authority submitted the replies on 27.07.2007. It was observed that they linked a few observations with Greater Noida Phaase-II Master Plan which was not submitted by the concerned Authority. Accordingly, Government of U.P./concerned agency was requested to submit the Master Plan for Greater Noida Phase-II for examination of Master Plan Phase-I. response was received, CEO, G. Noida was requested again on 8.8.2008, 23.10.2008, 1.4.2009 and 15.5.2009. CEO, G. Noida vide letter dated 11.6.2009 informed that the G. Noida has termed this area as expansion of Greater Noida Phase-I and a revised Development Plan is under preparation. Greater Noida Authority informed that this be submitted to the Board as soon as it is prepared. It was also informed that this exercise will take at least six months.
- 3. The matter was reviewed in the 57<sup>th</sup> Planning Committee meeting held on 29.12.2009 and it was decided that Commissioner, NCR Cell, U.P. will interact with the G. Noida Authority and ensure that the observations of the Planning Committee are incorporated in the draft Master Plan for G. Noida-I and II before submitting the Master Plan to the NCR Planning Board for consideration. Copy of the Minutes is at Annexure-3/II.
- 4. Several cases on related to land acquisition were filed in the Hon'ble Allahabad High Court. The draft Master Plan for Greater Noida-2021 has been submitted to the Board on 14.12.2011 in view of the Hon'ble Allahabad High Court Judgement dated 21.10.2011 in the Writ Petition (C) 37443/2011 and other Petitions filed in the Hon'ble High Court, Allahabad against the land acquisition by the Greater Noida Authority. Total number of petitions as listed in the orders is 471 which have been bunched into 65 groups. Relevant paras of the directions of the Hon'ble High Court are re-produced below:

"The Greater NOIDA and its allottees are directed not to carry on development and not to implement the Master Plan-2021 till the observations and directions of the National Capital Region Planning Board are incorporated in Master Plan-2021 to the satisfaction of the National Capital Region Planning Board. We make

it clear that this direction shall not be applicable in those cases where the development is being carried on in accordance with the earlier Master Plan of the Greater NOIDA duly approved by the National Capital Region Planning Board.

We direct the Chief Secretary of the State to appoint officers not below the level of Principal Secretary (except the officers of Industrial Development Department who have dealt with the relevant files) to conduct a thorough inquiry regarding the acts of Greater Noida (a) in proceeding to implement Master Plan-2021 without approval of National Capital Region Planning Board, (b) decisions taken to change the land use, (c) allotment made to the builders and (d) indiscriminate proposals for acquisition of land, and thereafter the State Government shall take appropriate action in the matter." (Page 386-387 of order)

Though there is no specific direction by the Hon'ble Court to the NCR Planning Board but it clearly says that till the observations and directions of the NCR Planning Board are incorporated in the Master Plan to the satisfaction of the NCR Planning Board, no development to be carried out for implementation of the Master Plan-2021. The provisions of the NCR Planning Board Act, 1985 and the provision of Regional Plan-2021 have been examined by the Hon'ble Court from Para 4 of Page 211 of the order onwards. Extracts of relevant examination of land uses analysis given in the Regional Plan-2021 and Section 40 of the NCR Planning Board Act, 1985 is at **Annexure-3/III**.

- 5. In view of the order of the Hon'ble Court, the Industrial Development Department, Govt. of UP vide letter dated 11.11.2011 (Annexure 3/IV.) submitted the amended Greater Noida Master Plan 2021 for no objection. Subsequently CEO, GNIDA vide letter dated 14.11.2011(Annexure 3/V.) referring to the letter of Industrial Development Department, Govt. of UP, dated 11.11.2011 submitted certain facts for granting NOC/expressing satisfaction with regard to conformity of Greater Noida Master Plan 2021 with Regional Plan 2021. As the Plan was not examined by the Housing & Urban Planning Department, Government of U.P. and NCR Cell, Ghaziabad, U.P., Board requested Principal Secretary, Housing & Urban Planning Department, Govt. of UP vide letter dated 19.11.2011 to examine the Plan with reference to the observations of the Planning Committee as well as examine the Plan for ensuring the conformity with the Regional Plan-2021. Reminders were sent to Government of U.P. on 1.12.2011 & 12.12.2011 in this regard.
- 6. Principal Secretary, Housing & Urban Planning Department, Govt. of UP vide letter dated 14.12.2011 (Annexure 3/VI) has now forwarded the amended draft Greater Noida Master Plan for 2021 for consideration of the Planning Committee of the NCR Planning Board. It has been specifically mentioned in the letter of Govt. of UP that the amended draft Master Plan for Greater Noida-2021 is in conformity with the Regional Plan-2021 except in terms of density.

- 7. Draft Master Plan for G. Noida-2021 has been examined with reference to the observations raised by the Planning Committee in its earlier meeting and in reference to the observations/examination/comments of the Hon'ble Allahabad High Court Judgement dated 21.10.2011. A comparative table indicating the observations of the Planning Committee, replies/updated replies of G. Noida/Government of U.P. and comments of the Board are at Annexure-3/VII. Comments on the Amended Draft Greater Noida Master Plan-2021 submitted on 14.12.2011 are at Annexure-3/VIII. Broad Salient Features of the Draft Amended Master Plan for Greater Noida-2021 are at Annexure-3/IX.
- 8. In view of detailed comments given from i) to xi) in Annexure-3/VII and 1 to 8 in Annexure-3/VIII, decisions may be taken by the Planning Committee. The replies/justifications given by the State Government has been examined and listed in the observations of the NCR Planning Board in these Annexures.

#### **Action Point**

The matter is placed before the Planning Committee for consideration. The recommendations of the Planning Committee will be placed before the Board for a final decision.

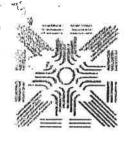
## AGENDA ITEM NO.4: STATUS OF PREPARATION OF SUB-REGIONAL PLANS

- i) According to Section 17 of NCRPB Act, 1985 each participating State is required to prepare Sub-Regional Plan for their respective Sub-region after finalization of the Regional Plan which was notified on 17.9.2005 for perspective 2021. On the request of the NCR participating States for preparation of Sub-Regional Plan through outsourcing in a time bound manner, the matter was placed before the PSMG-I in its 39<sup>th</sup> meeting held on 25.7.07. The PSMG-I accorded in-principle approval with a maximum of Rs.54 lakhs for each sub-region from NCRPB and additional cost if any on the preparation of the Sub-Regional Plan will be borne by the respective State Governments. Accordingly, the State governments were requested to take further action for preparation of Sub-Regional Plans through outsourcing. All the participating State Governments have awarded the work of preparation of Sub-Regional Plans of the respective Sub-regions.
- ii) Sub-Regional Plan for Haryana Sub-Region: Draft Final Report for this Sub-region has been prepared and our comments on the same have been conveyed to Government of Haryana vide NCRPB's letter dated 29.11.2011. Modified draft Sub-Regional Plan for Haryana is awaited from Government of Haryana.
- iii) Sub-Regional Plan for Rajasthan Sub-Region: Stage-II Report has been submitted by the Consultant to the Government of Rajasthan and it was considered in the CRC meeting held at Jaipur on 17.2.2012. Minutes are awaited.
- iv) Sub-Regional Plan for NCT of Delhi: In the last meeting of the NCR Planning Board held on 11.11.2009, the Board observed that few aspects like inter-state connectivity, inter-state issues had not been incorporated in the MPD-2021 which could be incorporated in the MPD-2021 as Addendum. Board decided that addendum be prepared incorporating the above mentioned aspects which would be a part of the Master Plan for Delhi. Board vide letter dated 06.08.2011 made a request to Commissioner Planning, DDA for the status of the preparation of the Addendum to MPD-2021. The representatives from the participating States/ DDA may give the status of preparation of Sub-Regional Plans/ Addendum to MPD-2021 for their respective Sub-regions.
- v) Sub-Regional Plan for UP Sub-Region: Government of U.P. has submitted the Draft Sub-regional Plan-2031 for U.P. Sub-region vide its letter dated 31.1.2012 which is being examined.

i) Draft Master Plan for Greater NOIDA 2021

Chief Town & Country Planner, Govt. of UP stated that the Master Plan for Greater Noida has been submitted to the NCR Planning Board. On a query regarding examination of the Master Plan by the NCR Cell, UP by the Chairperson, the Chief Town & Country Planner, Govt. of UP explained that the NCR Cell has examined the Master Plan and they had given their observations and suggestions to the Greater Noida Authority and these have been incorporated in the Plan. He further submitted that in view of the High Court decisions the matter may be given priority. Chairperson suggested that observations and suggestions of NCR Cell, UP on the Master Plan of Greater Noida need to be sent to the Board. She further stated that it should be ensured that the Master Plan of Greater Noida-2021 is in conformity with the Regional Plan-2021 in accordance with Section 29 of the NCR Planning Board Act, 1985.

After discussions, Committee directed that the State government to examine the Plan to ensure its conformity with Regional Plan-2021.

The Planning Committee noted.

The Planning Committee noted.

## iv) Preparation of District Plans as per the 74th Amendment of the Constitution

The Planning Committee noted.

## v) Development of Highway Corridor Zones

Chief Town & Country Planner, Govt. of UP while giving the status mentioned that the Highway Corridor Zone along NH-24 has been notified in September, 2009 and NH-58 is under consideration and will be notified shortly and other Highway Corridor Zones are under the delineation and notifications. Chairperson suggested that notifications of the areas already notified as Highway Corridor Zones and detailed status of other zones be sent to the Board.

Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana informed that 135 km long Kundli-Manesar-Palwal Corridor certain areas have been delineated and will be notified in about 3 months time. He further informed that no such exercise has been undertaken for other Highway Corridor Zones.

Chief Town Planner, NCR, Govt. of Rajasthan informed that he would provide detailed status on this matter. Chief Regional Planner, NCRPB suggested that Development Plan for this Highway Corridor Zone may be prepared and a presentation may also be given to the Board.

After detailed discussions, it was decided that the all the Highway Corridor Zones be delineated, notified and Development Plan prepared in a time bound manner by all the NCR participating States. Detailed Plan of Action on this matter be sent to the Board.

The matter of Draft Policy for Promoting Greenfield Townships prepared by TCPO, Govt. of India was discussed. Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana mentioned that nine cities along the KMP Expressway are being planned/developed by Govt. of Haryana however the policy circulated is not workable. He mentioned that government's role only as facilitator in implementation of the policies would not be feasible as Govt. of Haryana itself is developing infrastructure and townships in Haryana. Chief Town & Country Planner, Govt. of UP mentioned that the Govt. of UP is developing three Hi-Tech Townships in NCR which could be located within the notified development areas. New townships are being developed which could be located outside the notified development areas and New Township Development Authority has also been constituted for this purpose.

It was informed by Chief Regional Planner that Govt. of UP submitted their comments but they were not specific. The suggestion should be more focused to improve the policies. He further added that no comments have been received from the other State.

Chairperson suggested that Draft Policy circulated for Promoting Greenfield Townships may be examined by all the members of the Planning Committee and their comments and suggestions may be sent to the Board within a month's time so that the policy may be finalized. vi) Other issues related to implementation of Regional Plan-2021

(1) Work Plan for Solid Waste Management in NCR

Planning Committee noted.

(2) Work Plan for Drinking Water Supply in NCR

Planning Committee noted.

(3) Functioning of the existing STPs and CETPs and Work Plan to bring it to desirable standards/sanitation Master Plans.

Planning Committee noted.

(4) Strategies for re-development

Planning Committee noted.

(5) Capacity Building through pilot projects in Urban Planning and learning for doing strategy-Work Plan for NCRPB

Planning Committee noted.

(6) Innovative methods to fund NCR towns-Transferable Development Rights, land as resource, Municipal Bonds, Financing and PPP

Planning Committee noted.

(7) Strategies to develop/conserve wet land habitat, bio-diversity, river/water fronts etc.

Planning Committee requested the participating States to expedite delineation of Conservation Zone and preparation of Conservation Plan for Wetland and Conservation Areas.

vii) Issues raised by Additional Commissioner, NCR Planning & Monitoring Cell, UP regarding Provision of 30 mt. wide green belt on either side of the railway lines.

Planning Committee noted.

AGENDA ITEM NO.3: FUNCTIONAL PLAN FOR GROUND WATER RECHARGE

The status of implementation of the Functional Plan was reviewed. It was informed that rainwater harvesting has been made mandatory in HUDA areas. Representative from Govt. of UP informed that rainwater harvesting has also been made mandatory in UP Sub-region since 2001.

It was observed that although RWH structures are constructed because they are mandatory, but most of them are not functioning due to silting and lack of maintenance. In view of this, there is a need to review the efficacy and designs of water harvesting structures at micro level, especially in urban areas.

It was observed that a number of RWH were constructed in Delhi in the flyovers and other buildings during the Commonwealth Games, but these structures are not functional due to lack of maintenance. It was suggested that third party evaluation/ monitoring of such structures should be carried out. It was decided that the Board would write to State Governments of NCR participating States in this regard.

It was also decided that the latest data on status of groundwater levels in NCR should be obtained from Central Ground Water Board, since the earlier data is for 2005 and is outdated.

Principal Secretary, Govt. of Haryana informed that Ghaggar Standing Committee under the Ministry of Water Resources, Govt. of India had prepared three proposals for checkdams, which could be taken up for implementation for the groundwater recharge.

Different methods of sustainable management of ground water resources were discussed. It was suggested that sustainable level of ground water extraction should also be specified. It was discussed that water balance study should be part of the DPRs of Greenfield towns. Canal networks should be used to recharge ponds and buildings should be zero discharge buildings. Bye-laws of all Municipalities in the NCR need to include zero-discharge norms and mandatory rainwater harvesting.

It was felt that NOIDA and Gr. NOIDA areas are very well endowed with ground water resources and therefore these areas should be conserved and developed. Plans for making water available from this region to the rest of NCR could be prepared. The authorities were requested to examine this aspect.

## AGENDA ITEM NO.4: CONSIDERATION OF DRAFT FUNCTIONAL PLAN FOR WATER FOR NCR

After detailed discussions, the Functional Plan for Water for NCR was approved by Planning Committee for placing before NCR Planning Board in its next meeting.

AGENDA ITEM NO.5: FUNCTIONING OF THE EXISTING STPs AND CETPS AND WORK PLAN TO BRING IT TO DESIRABLE STANDARDS/SANITATION MASTER PLANS.

It was decided that the State Government / agencies will prepare Integrated Waste and Sanitation Master Plan and also provide the current status of performance of STPs and CETPs. Representative from CPCB was also requested to submit the status of performance of STPs and CETPs in NCR states.

### AGENDA ITEM NO.6: SOLID WASTE MANAGEMENT IN NCR

Representative of CPCB was requested to provide the details like survey no. of the common solid waste distribution sites identified by the Consultant in their report within one month. State Governments were requested to prepare Solid Waste Management Plan and Action Plan for their towns.

## AGENDA ITEM NO. 7: CONSIDERATION OF THE MODIFICATIONS I.E. CHAPTER-18 ON COUNTER-MAGNET AREAS IN THE REGIONAL PLAN-2021 FOR NCR

The representative of Planning Commission suggested that expressions "In other words, increased employment opportunities are getting created in the NCR States that have led to reduction in migration to NCT-Delhi. The reduced level of migration to the NCT-Delhi is a very positive outcome of development of areas adjoining the NCT-Delhi, on page 165 under para 18.3.5 may be deleted. The Planning Committee considered the modifications i.e. Chapter -18 on Counter-Magnet Areas in the Regional Plan-2021 for NCR and recommended for placing the same before the Board for approval.

## SUPPLEMENTARY AGENDA ITEM NO. 1: REVIEW OF STATUS FOR DEVELOPMENT OF CMAS

Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana mentioned that the distance between Ambala and Patiala is about 24 km and 8 km stretch falls in Ambala district. The remaining 16 km stretch there is no much development. The Govt. of Haryana has already prepared Development Plan for the controlled area of Ambala City. With regard to Hissar CMA, he mentioned that Development Plan has already been published. Chief Regional Planner, NCRPB mentioned that Plan of Action for development of Hissar and Ambala may be prepared and projects may be formulated for development.

Municipal Commissioner, Hissar informed that Water Supply & Sewerage Scheme with an estimated cost of Rs. 600 crores was prepared by PHED Department and submitted to the Govt. and he would be pursuing the project.

Chief Town & Country Planner, Govt. of UP informed that Bareilly-Rampur Corridor covering about 57 villages have been identified and will be notified shortly and Kanpur-Lucknow Corridor has also been identified.

Senior Town Planner, Town & Country Planning Department, Govt. of Uttarakhand informed that their government is in the process of identification of Dehradun Counter Magnet Area.

Chairperson suggested that the Counter Magnet Areas/Corridors may be delineated on priority and Development Plan and Plan of Action be prepared. She stressed that after the formalities are completed, projects be formulated for development of infrastructure and submit to the NCRPB for financial assistance.

The meeting ended with a vote of thanks to the Chair.







The Chairman welcomed the members to the 54<sup>th</sup> meeting of the Planning Committee and requested the Chief Regional Planner, NCRPB to take up the agenda items for discussion.

AGENDA ITEM NO.1: CONFIRMATION OF THE MINUTES OF THE 53<sup>RD</sup> MEETING OF THE PLANNING COMMITTEE HELD ON 5.5.2005.

It was informed that there were no comments/suggestions received in regard to the minutes of the 53<sup>rd</sup> meeting of the Planning Committee held on 5.5.2005. The minutes were confirmed.

AGENDA ITEM NO.2: REVIEW OF ACTION TAKEN ON THE DECISIONS OF THE 53<sup>RD</sup> MEETING OF THE PLANNING COMMITTEE HELD ON 5.5.2005.

## i) Preparation of Sub-Regional Plans

Chief Regional Planner, NCRPB informed that a seminar on preparation of Sub-Regional Plans was held on 29.8.2006 and the representatives from all the NCR participating States participated. He further informed that in nine and half months from the date of seminar, the draft Sub-Regional Plan (SRP) should be presented to the Board. The target date as decided in the seminar should be adhered to and the Steering Committee. High Level Group, Monitoring Committee and Study Groups may be notified expeditiously so that nork on preparation of SRP may be initiated at the earliest. The studies may be identified and Terms of Reference (TOR) for the identified studies may be prepared and submitted to the Board along with Request for Proposal (RFP) as finalized in the Seminar. He further informed that a copy of presentation was provided to the participants to facilitate them to initiate action on formation of various Committees and Groups and preparation of Sub Regional Plan.

2. Principal Secretary, PWD and L&B, GNCT-Delhi raised a query that in view of the MPD-2021 which covers the planning of entire NCT-Delhi whether there is a need for preparation of SRP for NCT-Delhi. Chairman, Planning Committee clarified that under the NCRPB Act, 1985 GNCT-Delhi is required to prepare SRP for NCT-Delhi which will cover the entire NCT-Delhi. He further clarified that this SRP will have to be prepared on the basis of the configuration of land uses got approved by the DDA in the Master Plan-2021 from the competent authority with focus on projected infrastructure needs relating to power, integrated water management system, sewerage, sanitation, solid waste disposal, drainage, multi-modal transport system, telecommunications, health and education alongwith strategies for fulfilling these needs. Moreover, the SRP should also lay emphasis on conservation of cultural heritage given the rich historical legacy of

Delhi. The SRP for Delhi may examine the possibility of undertaking joint sector projects with the NCR States in the sphere of infrastructure development and management.

- 3. The Commissioner & Secretary, T&CP. Govt. of Haryana mentioned that Govt. of Haryana has already identified road links with Delhi and the matter has been taken up with the GNCT-Delhi which needs to be expedited. Chairman noted the matter and said that the SRP for the Haryana Sub-region to be prepared by the State Govt. should incorporate the road links settled between the governments of Delhi and Haryana through consensus.
- 4. Associate Town & Country Planner, NCR Cell, Delhi informed that the Zonal Development Plan has been notified by the DDA for inviting objections/suggestions from public. In the Draft Zonal Development Plan, a provision of 80 m. wide road for the Mehrauli-Gurgaen road has been kept. In the case of Mandi road, a provision of 30 m. wide road has been kept within urban stretch and 20 m. wide road for the areas outside the urban area.
- 5. Chairman, Planning Committee informed that Board has constituted a High Powered Group for developing common approaches to problems of water resources management, power, transportation and pollution amongst the constituents of NCR Planning Board. He further informed that an Empowered Committee of the Board under the chairmanship of Secretary (UD), Ministry of Urban Development has also been constituted to take decisions about critical activities essential for making the NCR a region of global excellence.
- ii) Draft Zonal Development Plan for Zone 'O' and Part 'P' of MPD-2001.

Chief Regional Planner, NCRPB informed that Board has already sent its comments / objections to DDA with reference to the Agenda notes for the DDA meeting. Chairman, Planning Committee suggested that Board may send its observations on the Draft Zonal Development Plan for Zone 'O' and Part 'P' of MPD-2001 in response to notification issued by DDA for inviting objections/suggestions.

- iii) Status report on development of land use change sites approved by the Board The Planning Committee noted the status.
- iv) Development of City forest

Chairman, Planning Committee informed that under the City Forest Development Scheme, 100% grant was given to the Implementing Agencies. A team of officers from the NCRPB will be visiting projects which have reached an advanced stage.

v) Observations of the Board on the objections/suggestions received from public/local budies on draft Regional Plan - 2021.

Chief Regional Planner, NCRPB informed that Board has already taken action on this matter and the final RP-2021 was notified on 17.9.2005 and the copies of the same were circulated to all the members of the Board and participating State Governments for implementation of the policies and proposals of the Regional Plan 2021.

vi) Proposal for change of land use for an area measuring 37.0 ha. (91.4 acres) in Zone 'O' of MPD-2001 from 'agriculture & water body' (A-4) to 'residential' for slum resettlement at Madanpur Khadar, Delhi.

Planning Committee noted the status.

**AGENDA ITEM NO.3:** CONSIDERATION OF CHANGE OF LAND USE OF 430.71 HA. LAND OF VILLAGES JANAKSINGHPURA, MADHOSINGHPURA, KALI PAHARI AND MAJRA KATH. TESHIL BEHROR FROM 'AGRICULTURAL (RURAL) ZONE WITHIN CONTROLLED/DEVELOPMENT/REGULATED AREAS' **AREAS** OF SHAHJAHANPUR-NEEMRANA-BEHROR URBAN **COMPLEX** TO 'URBANISABLE AREA' (INDUSTRIAL) IN NCR RP-2021.

Chief Town Planner, NCR Cell, Govt. of Rajasthan presented the proposal. While presenting the proposal, the Chief Town Planner stated that RIICO already had a developed an industrial estate in Neemrana and now proposes to develop about 431 ha. of industrial land along the National Highway 8 as per their expansion programme. Land has already been acquired. Chairman suggested that since the site falls within the notified area of Shahjahanpur-Neemrana-Behror Urban Complex and a consultant has been appointed for carrying out a detailed study which will provide critical inputs for preparation of Master Plan for Shahjahanpur-Neemrana-Behror Urban Complex, it would not be appropriate to consider the change of land use of the proposal unless the site is considered suitable for industrial development as an outcome of the decisions taken on the said Study. Chairman suggested that as far as possible prime agricultural land should not be used for industrial/urban development purposes. He further suggested that a road link to Bhiwadi from Shahjahanpur-Neemrana-Behror Urban Complex through Rajasthan territory may be constructed which will open up the area in-between Bhiwadi and Shahjahanpur and boost the economy of the Rajasthan Sub-region.

AGENDA ITEM NO.4: CONSIDERATION OF CHANGE OF LANDUSE OF 7,200 SQ.M. AGRICULTURAL LAND LOCATED IN KHASRA NO.455 & 458, VILLAGE DOOGHERA, TEHSIL BEHROR FROM 'AGRICULTURAL (RURAL) ZONE WITHIN CONTROLLED / DEVELOPMENT / REGULATED AREAS OF SHAHJAHANPUR NEEMRANA-BEHROR URBAN COMPLEX TO 'URBANISABLE AREA' (PUBLIC & SEMI-PUBLIC) IN NCR REGIONAL PLAN 2021.

Chief Town Planner, NCR Cell, Govt. of Rajasthan presented the proposal. While presenting the proposal, he mentioned that Rath International School had been functioning in village Dooghera and the proposed area was for its expansion. Chief Regional Planner, NCRPB mentioned that a village road runs between the existing School campus and the proposed expansion site and suggested that a sub-way may be constructed to ensure the safety of the school children.

- 2. The Planning Committee recommended the proposal for change of landuse of 7,200 sq.m. agricultural land located in khasra no.455 & 458, village Dooghera, tehsil Behror from 'agricultural (rurai) zone within controlled / development / regulated areas of Shahjahanpur Neemrana-Behror Urban Complex to 'urbanisable area' (public & semi-public) in NCR Regional Plan 2021, on the condition that a sub-way may be constructed to ensure the safety of the school children and the public & semi-public (school) use may be suitably incorporated in the Master Plan of Shahjahanpur-Neemrana-Behror Urban Complex.
- 3. The proposal along with the recommendations would be put up before the Chairman, NCRPB and Hon'ble Minister for Urban Development for approval.

AGENDA ITEM NO.5: CONSIDERATION OF CHANGE OF LANDUSE FOR AN AREA MEASURING 270.23 HA. IN VILLAGES BALLABODA DHOLIDOOB, TULEDA AND ALWAR NO.1, TEHSIL ALWAR FROM 'AGRICULTURAL (RURAL) ZONE WITHIN CONTROLLED / DEVELOPMENT / REGULATED AREAS' OF ALWAR URBAN AREA TO 'URBANISABLE AREA' (RESIDENTIAL) IN NCR REGIONAL PLAN 2021 FOR 4 MULTIPURPOSE RESIDENTIAL SCHEMES OF UIT, ALWAR.

Chief Town Planner, NCR Cell, Govt. of Rajasthan presented the proposal. While presenting the proposal; he mentioned that the proposed sites of the four multipurpose residential schemes are located within the notified urban area (controlled area) of Alwar Master Plan 2001 and falls in the 'peripheral controlled belt'. With regards to water availability he mentioned that as per the CGWB, this area has been categorized as over exploited. The water table ranges between 35 to 42 m. and expected discharge from the tube well various between 9 to 15 kiloliters per hour. The water quality is potable and slightly saline. UIT, Alwar has estimated the projected population of 56000 persons in the four schemes and water requirement works out to about 11200 kiloliters per day. It is proposed to construct 40 tube wells to meet the water requirement. Chief Town Planner, NCR, Rajasthan Sub-region informed that the proposed area of the four schemes is contiguous to the proposed urbanisable area of Alwar Master Plan and these schemes are required to achieve the planned development of Alwar town and provide plots to the residents of Alwar at a reasonable rates.

2. Chairman observed that the adjoining area of the schemes falling within the 'urbanisable area' of Alwar Master Plan has been shown as 'industrial areas' and enquired its status of development. The representative from UIT, Alwar informed that this 'industrial area' had been converted to 'commercial use' and other uses earlier. Chairman suggested that UIT, Alwar/ Govt. of Rajasthan may inform the status of development of 'industrial area' and its conversion to 'commercial area' and other uses to the Board in writing.

3. After detailed deliberations, the Member Secretary, NCRPB was authorized to decide the further line of action after the status report is submitted by the State government and examined in the Board and the matter is discussed with the senior officers of the Govt. of Rajasthan.

## AGENDA ITEM NO.6: REGIONAL PLAN 2021 NORMS AND STANDARDS FOR DEVELOPMENT OF URBAN CENTRES/NEW TOWNSHIPS IN NCR

The Planning Committee directed the NCR member States to follow the norms and standards for development of urban centres/new townships in NCR as proposed in this item as well as proposals given in the Regional Plan 2021.

### SUPPLEMENTARY AGENDA ITEM NO.1: CONSIDERATION OF DRAFT MASTER PLAN -2021 FOR GREATER NOIDA

General Manager (Planning & Architecture) presented the proposals of the draft Master Plan 2021 for Greater Noida. While presenting the draft Master Plan, she mentioned that the Greater Noida is a Metro City located outside the CNCR and has been planned as low density city with extensive green areas and with openness so as to act as a lung space for the NCR and attract the people who reside in high density, congested areas of Delhi and other CNCR towns. With regards to inter city linkages, a number of links has been proposed from NOIDA, Ghaziabad and Delhi. For intra-city movement, a road with 130 m. width has been proposed as backbone of the linear city for connecting northern and southern parts and also to NOIDA and Delhi. A Light Rail Transit (LRT) system has been proposed for Noida City Centre to Greater Noida. General Manager (Planning & Architecture) stated that Greater Noida has already prepared detailed Master Plan for Infrastructure Development such as Transport, Water Supply and Sewerage for implementation of the Master Plan proposals.

- 2. After detailed deliberations, the Planning Committee made the following observations/suggestions:
- i) A green buffer of about two km. width should be kept between the urbanisable areas of Noida and Greater Noida along the Hindon river.
- ii) While preparing the detailed plans, a green buffer of suitable width between industrial area and the residential areas on the northern side of the proposed Greater Noida Land use Plan should be kept to act as a barrier for pollution. Suitable areas should be earmarked for IT industries in this industrial zone.
- iii) Land / plots for another industrial units should be earmarked where the smaller units may be relocated.

- iv) The area between the railway line and the GT road has been kept as agriculture land outside the notified area which may be prone for unauthorized constructions. It was suggested that the area between the railway line and the GT road may be notified and kept as an agricultural green belt.
- v) In the southern part, a large chunk of land has been earmarked as 'industrial' bordering the residential sectors. It was suggested that a green belt of suitable width may be kept to act as a barrier for pollution.
- Orbital Railway Corridor proposed in the Regional Plan 2021 and Eastern Peripheral Expressway (EPE) to be incorporated in the Greater Noida Master Plan and alignment of the same may be marked on the proposed Land use Plan. Collector, Gautam Budh Nagar is the Nodal Officer for land acquisition for EPE and exact alignment would be available with him giving exact Khasra numbers etc. NCRPB would also request Ministry of Shipping, Road Transport and Highway to provide alignment to the Board. In the Regional Plan-2021, it is proposed that the alignment of the Orbital Rail will be parallel to Peripheral
- vii) It was suggested that BRT system may be adopted for smooth intra city traffic movement. The cross section of the proposed road including the BRT system needs to be provided for all categories i.e. expressway, arterial, sub-arterial of roads. It was also suggested that suitable provision may be kept for non motorized transport (NPT) and slow motorized traffic (SMT) in the Master Plan.
- viii) Since Greater Noida is being planned for the hi-tech housing/residential, it would be appropriate that suitable areas may be earmarked for the EWS and LIG categories as well as Group Housing Societies in the residential sectors of the Master Plan of Greater Noida and suitable percentages of residential areas should be mentioned in the written document of the Master Plan for EWS/IJG/Labour Housing and Group Lousing Societies.
- ix) In the Master Plan activities such a bus terminal, LRT Terminal, Multiplex/Cinema Halls etc. are permitted in recreational green areas. The Planning Committee suggested that bus terminal, LRT terminal, to be shown as Transport use and Cinema/Multiplex Halls to be shown as commercial use and kept out of the greens. However, limited, specific recreational activities related to sports/physical fitness can be incorporated.
- x) It was suggested that a negative list of industries (non permitted) in the Greater Noida may be prepared and enclosed in the Greater Noida Master Plan document.

- The Planning Committee observed that the Govt. of UP is proposing to develop Greater Noida Phase-II adjacent to present Greater Noida notified area. It was suggested that a provision of green buffer of about 5 km. width may be kept along the boundaries of the notified area of Greater Noida and Greater Noida Phase-II.
- 3. The Planning Committee decided that the GNIDA Authority will modify the Greater Noida Master Plan 2021 after incorporating the above mentioned suggestions and submit the same to the NCRPB. The Planning Committee authorized the Member Secretary, NCRPB to take a decision in the matter after the modified draft Master Plan 2021 for Greater Noida is submitted by Govt. of UP/NCR Cell, UP.

The meeting ended with a vote of thanks to the Chair.



MINUTES OF THE 5<sup>TH</sup> MEETING OF THE PLANNING COMMITTEE HELD AT 11.00 A.M. ON 29.12.2009 IN THE CONFERENCE HALL OF NATIONAL INSTITUTE OF URBAN AFFAIRS, CORE-IV B. FIRST FLOOR, INDIA HABITAT CENTRE, LODI ROAD, NEW DELHI-110003.

Chairman welcomed the members of the Planning Committee. Chairman emphasized that the Statutory Planning Committee has an important role to play in the implementation of the various policies and proposals of the Regional Plan 2021 and other various plans. Keeping this view, a number of issues have been added in the agenda items for deliberations in the meeting. Thereafter, the Planning Committee took up the agenda items for discussions.

AGENDA ITEM NO.1:

CONFIRMATION OF THE MINUTES OF THE 56<sup>TH</sup> MEETING OF THE PLANNING COMMITTEE HELD ON 19.9.2008

The Minutes of the 56° meeting of the Planning Committee held on 19.09.2008 were confirmed.

AGENDA ITEM NO.2:

REVIEW OF ACTION TAKEN ON THE DECISIONS OF THE 56<sup>TR</sup> MEETING OF THE PLANNING COMMITTEE HELD ON 19.9.2008

### Draft Master Plan for Greater NOIDA 2021

Chief Regional Planner. NCRPB while explaining the status of preparation of the draft Master Plan for Greater NOID 4-2021 mentioned that the Planning Committee in its 54th meeting 04.09.2006 suggested that the green belt should be kept between Greater Noida Phase I & II. The other proposals like Orbital Rail. Dedicated Freight Corridor (DFC) and Peripheral Expressway should be incorporated in the Master Plan. The Planning Committee suggested that all the observations should be incorporated in the Master Plans.

Chairman suggested that Transferable Development Rights (TDR) method can be applied for the provisions of green belt in the Master Plan so that the owners of the land falling within the green belt are not adversely affected. He further mentioned that TDR method is being practiced by the development authorities in Rajasthan. Chairman suggested that the development authorities / agencies of the towns in NCR should be involved in discussion regarding the adoptability of the TDR which could be used for maintaining the green area, and other purposes like road widening, slum area, heritage area and even affordable housing.

Chairman further mentioned that the various provisions like earthquake resistant structures, fire fighting exists in the Master Plans / Regulations but enforcement of the provisions need to be ensured.

Principal Secretary, Housing & Environment, Govt. of M.P mentioned that the Government of MP is in the process of preparation of Rules regarding premium on FAR, development fees and creation of development fund, etc. and mentioned that the Rules once finalized, a copy of the same would be sent to the NCRPB. Stating the transparency in planning process he mentioned that in Machya Pradesh pre-plan workshops are organized before the actual

plan preparation and subsequently a draft plan is prepared, public suggestion i objections are invited, public hearings are also held by a committee constituted for this purpose. Chairman suggested that in compliance of the RP-2021 the Master Plan Development Plans, the NCR Cells could be involved in the planning process.

Director (A&F). NCRPB suggested that Infrastructure Development Plans / Sectoral Plans should be prepared at a time-bound manner after the Master Plan of Greater Noida 2021 is finalized so that specific projects are formulated for implementation of the Plan proposals.

After detailed deliberations, it was decided that the Commissioner, NCR Cell, UP will interact with the Greater Noida Authority and ensure that the observations of the Planning Committee are incorporated in the draft Master Plan for Greater Noida Phase-II before submitting the Master Plans to the NCR Planning Board for consideration.

# ii) Study report on Counter-Magnet Areas to Delhi and National Capital Region (NCR)

Chief Regional Planner, NCRPB mentioned that Board had approved the recommendations of the 56° Planning Committee on the Study on Counter-Magnet Areas to Delhi and NCR along with the draft chapter on Counter-Magnet Areas for incorporation in the Regional Plan-2021 for NCR in its 31° meeting held on 11.11.2009. In pursuance to the decision of the Board, necessary action is being taken for notifying the modification in the chapter related to "Counter-Magnet Areas" i.e. Chapter-18 Regional Plan-2021 for NCR for inviting objection and suggestions from the public as per section 14 (2) and the provisions of the NCRPB Act, 1985 and Rule 23 to 26 of NCRPB Rules. 1985.

Chairman suggested that all the concerned states may prepare Plan of Action for Development of Counter Magnet Areas, simultaneously, so that the Plan of Action for development is ready by the time final Notification of Counter Magnet Area is issued.

# iii) Landuse change proposals in Rajasthan Sub-region received from Govt. of Rajasthan

The Committee noted that the Govt. of Rajasthan is in the process of preparation of Sub-Regional Plan and Master Plan for SNB Urban Complex and Greater Bhiwadi where the landuse change proposals will be suitably incorporated.

### AGENDA ITEM NO.3: REVIEW OF STATUS OF IMPLEMENTATION OF REGIONAL PLAN - 2021 FOR NCR

### (a) Steering Committee for implementation of policies & proposals of Regional Plan-2021 for National Capital Region

The Planning Committee noted that all the NCR participating States have constituted Steering Committees for their respective Sub-regions. The Committee observed that meetings of the Steering Committees were not held on quarterly basis. Chairman suggested that the progress of implementation of policies and proposals of Regional Plan-2021 are to be monitored effectively by the NCR Planning and Monitoring Cells of the participating States and report the same to the Steering Committee in their meetings on quarterly basis.

#### (b) Quarterly Progress Report

The Planning Committee observed that the Quarter Progress Reports are not being received by the NCR Planning Board regularly. Chief Regional Planner, NCRPB mentioned that Board has designed a format for submission of quarterly progress reports and already circulated to NCR Planning and Monitoring Cells of the participating States. Chairman suggested that NCR Planning & Monitoring Cells should interact with the various departments/agencies and closely monitor the implementation of the Regional Plan policies and proposals and obtain the Quarterly Progress Report from the concerned departments/agencies and consolidate the same and submit to the NCR Planning Board on quarterly basis. He also suggested to set up web based submission of progress reports in time.

#### (c) Preparation of Functional Plans for selective sectors

Chief Regional Planner, NCRPB while giving the status of preparation of Functional Plans membered that the Functional Plans for Transport and Ground Water Recharge were approved for further action by the Board in its meeting held on 11.11.2009. These Functional Plans will be circulated to the concerned Stakeholders shortly. The Functional Plans for Power and Water are being prepared in-house with the help of Study Groups. With regard to preparation of Functional Plan for Drainage, it was mentioned that data and information were not forthcoming from the States and Chairman suggested that the members of the Planning Committee may take up this matter to their concerned departments/agencies for expeditious supply of data and information to the NCR Planning Board for preparation of Functional Plan for Drainage.

### d) Preparation of Sub-Regional Plans-2021 for sub-regions of NCR

Financial Commissioner & Principal Secretary, Town & Country Planning Deptt., Govi of Haryana stated that the CRC has finalized the Interim Report-1 prepared by the Consultant. He further stated that the entire exercise would be completed in the next four months' time.

Addl. Commissioner, NCR Cell, UP had mentioned that Inception Report had been prepared by the Consultant and received in the office of the NCR Cell, UP. He further mentioned that the meeting of the CRC to consider the Inception Report would be held shortly.

The representative from Govt. of Rajasthan stated that Inception Report prepared by the Consultant had been received. The Interim Report is under preparation. The exercise of preparation of Sub-Regional Plan would be completed by May, 2010.

Chief Regional Planner, NCRPB mentioned that in the last meeting of the NCR Planning Board held on 11.11.2009, the Board observed that few aspects like inter-state connectivity, inter-state issues had not been incorporated in the MPD-2021 which could be incorporated in the MPD-2021 as Addendum. After discussions, the Board had decided that the addendum be prepared incorporating the above mentioned aspects which would be a part of the Master Plan for Delhi. The representative from DDA informed that he would intimate the action taken on preparation of Addendum to the MPD-2021 to the NCR Planning Board shortly.

### Preparation of Master/Development Plan for towns of NCR for the perspective year 2021 and its Work Plan

The Chairman stressed that in order to achieve the Plan development of the NCR, the Master Plans of all the towns should be prepared in a time bound manner which would help in effective of the implementation of the policies and proposals of RP-2021 for NCR.

Addi. Commissioner, NCR Cell, UP mentioned that as per the criteria set for preparation of Master Plan of towns in UP, 22 towns have been notified for preparation of Master Plan and the remaining towns would not fulfill the criteria to be eligible for preparation of Master Plans. Keeping in view dynamism of urbanization in the NCR, it would be appropriate that Master Plans/Development Plans are prepared for all the towns falling within the Sub-regions of NCR. As regards eligibility of criteria of the remaining towns for preparation of Master Plans, the matter may be examined by the NCR Cells and detailed note for preparation of Master Plans for the remaining towns may be sent to the NCRPB so that the matter can be taken up with the Govt. of UP

Financial Commissioner & Principal Secretary, Town & Country Planning Deptt., Govt. of Haryana informed that Master Plans of 28 towns have been prepared and those of other six towns are under preparation. The representative from Government of Rajasthan stated that Master Plans of Neemrana-Shahjanpur-Behror Complex, Alwar and Greater Bhiwadi were under preparation.

After detailed discussions, the Planning Committee decided that the NCR Cells of the master Development Plans and also prepare a Work Plan along with time schedule for preparation of Master Plans of all the remaining towns in their respective sub-regions. Difficulties, if any, may be communicated to the Board.

### (f) Others (Sub-Plans, Annual Plans & Action Plans and Projects Plans)

Chief Regional Planner, NCRPB mentioned that Sub-Plans, Action Plans, Annual Plans and Project Plans are required to be prepared for effective implementation of the Regional Plan policies and proposals. Chairman suggested that the constituent States may prepare these Plans particularly the basic services for Transport, Water Supply, Solid Waste Management etc. in a time bound manner so that projects are formulated based on these Plans.

## AGENDA ITEM NO.4: PREPARATION OF DISTRICT PLANS AS PER THE 74<sup>TH</sup> AMENDMENT OF THE CONSTITUTION

Chairman while explaining the importance of preparation of District Plans for effectuation of policies and proposals of the Regional Plan in the Sub-Regions, suggested that the constituent States may prepare District Plans for the Districts falling within the respective Sub-Regions. He stated that the Regional Plan also includes policies and proposals for development of nural areas in NCR to achieve balanced development of the region. The prevailing Town & Country Planning Acts in the States do not cover planning and development of the rural areas outside the notified controlled / development / regulated areas around the town. The District Plans prepared under the provisions of 73<sup>rd</sup> and 74<sup>th</sup> Constitutional Amendment Act will not only cover the universal areas but also cover planning, development and management of the fringe areas outside the controlled areas and rural areas outside controlled areas.

Principal Secretary, Govt. of Madhya Pradesh stated that the local bodies do not own the lands in the periphery of the towns. The District Plans would help in development of the urban fringe areas and the rural areas in a planned manner.

Financial Commissioner & Principal Secretary, Town & Country Planning Deptt., Govt. of Harvana raised the issue of funding for implementation of the various proposals of the District Plans. Chairman mentioned that the various Departments/Agencies at district level are involved in planning and development of their own sectors. The District Plan can be prepared by integrating the proposals / plans of various Departments/Agencies. Chairman suggested that District Plan for at least one District in each Sub-Regions of UP, Haryana and Rajasthan may be prepared in the coming few months.

Chief Planner, TCPO, Ministry of Urban Development mentioned that TCPO has done some work on the District Plans which could be shared with the NCR constituent states. After detailed discussions, it was decided that TCPO in association with NCR Planning Board will organize a Seminar on preparation of District Plans where the Development Authorities. Municipal bodies and District Collectors of the Districts of NCR would also be invited.

### AGENDA ITEM NO.5: DEVELOPMENT OF HIGHWAY CORRIDOR ZONES

Chairman, keeping in view the rapid urbanization in the NCR particularly along the Highways, stated that the width of the Highway Corridor Zone should be more than 500 m on either side of the Highways as proposed in the Regional Plan. Quoting the examples of development of new townships along the KMP Expressway in Haryana Sub-region, he stated that in other Sub-regions sumitar type of township development can be taken up which would help in achieving induced development of the region in a planned manner. In order to avoid unantended developments along the Highways, Chairman suggested that the Highway Corridor Zones may be delineated, notified and Development Plans be prepared expeditiously.

Chief Planner. TCPO, Ministry of Urban Development informed that the TCPO is working on preparation of Guidelines for Development of Corridor Zones. Chairman requested him to send a copy of the Guidelines to NCRPB which could be provided to the NCR participating States for their guidance.

AGENDA ITEM NO.6:

OTHER ISSUES RELATED TO IMPLEMENTATION OF REGIONAL PLAN-2021

### Work Plan for Solid Waste Management in NCR /SWM in NCR

Chairman emphasized the need for development of common Solid Waste disposal sites in the NCR to solve the problem of solid waste disposal in smaller cities/towns. He mentioned that Central Pollution Control Board had undertaken a Study for identification of Common Landfill Size for towns in NCR and the Study Report is under finalization. Once this report is received it would be circulated to the NCR participating States to formulate the schemes for development of Common Landfill Site and if the need arises NCR Planning Board can be approached for financial assistance.

After detailed discussions, Planning Committee decided that NCR participating States/
Agencies Development Authorities/ULBs would prepare Sectoral Master Plan for Solid Waste
Management for the cities/towns in their Sub-region. The cities with population more than one

lakh may be taken up in the in the first instance and effort should be to ensure scientific disposal of solid waste in these towns in the current Five Year Plan.

### 2) Work Plan for Drinking Water Supply in NCR

Chairman informed that the study of Water Supply and its Management is being conducted and the final report will be the Functional Plan for Water in NCR. It is also proposed to hold a Workshop to share the draft final report with the stakeholders. After obtaining the inputs from the stakeholders, Final Report would be prepared and circulated. In order to detail out and identify projects for drinking water supply at city/local level, there is a need for preparation of Sectoral Master Plan on Water Management in the city. These would have to be prepared at the city/district level by the concerned State Governments/ their agencies.

It was also informed that the Functional Plan on Ground Water Recharge for NCR was approved in the 31st meeting of NCR Planning Board held on 11.11.09 and it was discussed in the Workshop held on 30.11.2009. It was decided that concerned District Collectors and other agencies of the State Government of NCR participating States would prepare Plan of Action at district level for ground water recharge in NCR, including identification of projects and source of funds from various governmental schemes such as NREGS of Ministry of Rural Development and schemes of Ministry of Water Resources and their implementation. The concerned agencies of the NCR states are requested to take action in this regard.

After detailed discussion it was decided that the NCR participating States would take action as decided.

### 3) Functioning of the existing STPs and CETPs and Work Plan to bring it to desirable standards/sanitation Master Plans.

The Chairman stated that all the towns of NCR should have sewerage system and the disposal should be only after proper treatment as per the standards. He observed that the treatment facilities in NCR towns are inadequate and also the existing STPs are not functioning properly. He further informed that Sewerage Master Plan for Hapur, U.P has been prepared by NCRPB through the technical assistance of ADB, and suggested that the Sewerage Master Plans for other towns may be prepared on the similar lines. NCRPB will conduct training programme for the officers of the participating States, through AMDA.

Director (A&F), NCRPB mentioned that the Sectoral Plans for infrastructure development like, sanitation plan including sewerage and solid waste management should be prepared for each of the towns in NCR based on which projects can be formulated through Project Development Facility (PDF) of NCRPB.

It was decided to circulate the Sewerage Master Plan of Hapur already prepared by the ADB Consultants, to all the participating States as a sample. The committee recommended that the participating States would prepare sewerage Master Plan and would implement the sewerage system in NCR towns in phased manner. The States would prepare the schemes for implementation of sewerage system in these towns and would ensure disposal of the effluent only after treatment as per the standards.

It was also decided that the States will take steps to improve functioning of the existing STPs / CETPs even by privatising its O&M wherever feasible and to use the treated water for non-drinking purposes instead of discharging it in the drains. A Plan would have to be prepared in this regard.

### 4) Strategies for re-development

Chief Regional Planner, NCRPB mentioned that a number of large cities in NCR were experiencing problems of congestion, limitation of land and cld structures particularly in the old cities / walled cities and old city centres which require immediate attention for re-development to revitalize the economy of the area and quality of life of the people. This requires delineation of old city areas/city centres of various cities and towns in NCR and preparation of Re-development Plan followed by re-development schemes/ projects. He further mentioned that the MPD-2021 has a provision for preparation of re-development scheme.

Chairman suggested that the participating States may initiate action for identification delineation of the areas for re-development in the various crites towns falling the respective Sub-regions and prepare re-development plan and initiate formulation of re-development schemes.

After detailed discussions, it was decided that the participating States will instate action for identification/delineation of the re-development areas and preparation of the Development Plans. It was also decided that a Committee under the Chairmanship of Chief Planner, TCPO. Ministry of Urban Development with the Chief Coordinator Planners/Chief Town Planner, NCR Cells of the participating States, Joint Secretary, NCR Cell, NCT-Delhi and Additional Commissioner (Planning), DDA and Joint Director, NCRPB would be constituted for formulation of Guidelines for preparation of Re-Development Plan.

## 5) Capacity Building through pilot projects in Urban Planning and learning for doing strategy – Work Plan for NCRPB

Chief Regional Planner NCRPB gave the background and stressed that Officers officials of the NCR Planning Board and NCR Constituent States may be trained on latest mapping technologies like Geographic Information System (GIS). He suggested that the training may be given through Indian Institute of Remote Sensing (IIRS). Dehraden which is a premier Govt. Institute in the field of Remote Sensing (RS) & GIS for Urban/Regional Planning. CRP also suggested that two weeks of training on GIS & RS would be required for the officers officials of the NCRPB and NCR Participating States.

Chairman suggested that capacity building of the NCRPB and the NCR Participating States should be done in the application of GIS in all Sectors. The capacity should be built to a level where RS, GIS and GPS technology is used. He mentioned that the use of GIS application should not be only for land planning but also could be for project planning/formulation. He further added that the training could be tailor made for senior officers, junior level officers and working level officers so that exposure is available at every level.

After detailed deliberations, it was decided that, to begin with, one training program is a year on GIS & RS would be taken up which can further he increased to two or even more programs in a year, as needed.

6) Innovative methods to fund NCR towns - Transferable Development Rights, land as resource, Municipal Bonds, Financing and PPP

Chief Regional Planner, NCRPB mentioned that Transferable Development Rights is a very useful tool which can be used for preserving green area, heritage area, reserved area, and area of road widening, etc. It has also been used successfully for development of sium area in case of Mumbai by Government of Maharashtra. Government of Rajasthan has made successful experiment for providing affordable housing to the weaker section through TDR. He further informed that the NCR Planning and Monitoring Cell, UP has prepared a proposal for protection of green belt on either side of highways as recommended in Regional Plan-2021 through the use of TDR. This can be suitably adopted by other States. He further mentioned that the matter of TDR was discussed in a meeting under the chairmanship of Member Secretary, NCRPB held on 21.12.2009 wherein two presentations were made. Copies of the presentations on "Draft Policy for Transferable Development Rights (Road Side Green Buffers in NCR) – (Appendix-I) and "Transferable Development Rights" (Appendix-II) are enclosed for guidance.

Director (A&F), NCRPB made a presentation on the Financing of Urban Infrastructure in NCR. In his presentation, he mentioned the infrastructure gaps in NCR which is estimated to the tune of Rs.300000 crores upto 2021 of which Rs. 22,800 crores would be required for the services like Water Supply. Sewerage, Drainage. Solid Waste Management etc. He had highlighted the major concern in the urban infrastructure and possible sources of financing urban infrastructure in NCR. A copy of the presentation is enclosed (Appendix-III).

### 7) Strategies to develop/conserve wet land habitat, bio-diversity, river-water fronts etc.

Chief Regional Planner. NCRPB mentioned that Regional Star be seen the sees' zones which should be conserved and protected and the Plan has also proposed that detailed Conservation Plans to be prepared for the areas designated as Variant Croan Conservation Zone in the Regional Plan-2021 for NCR.

Chairman suggested that utmost care should be taken for development around the ecologically sensitive nature conservation zones like ridge, forest, takes, water bodies, paleochannels which are required to be protected.

After detailed discussions, the Planning Committee decided that the respective State Governments/Agencies would delineate the conservation zones and initiate preparation of detailed Conservation Plan for the same. TDR may be used to implement such Plans wherever needed

Agenda Item No. 7 ISSUES RAISED BY ADDITIONAL COMMISSIONER, NCR PLANNING AND MONITORING CELL, UP.

Provision of 30 mt. wide green belt on either side of the railway lines.

The Additional Commissioner, NCR Planning and Monitoring Cell, UP suggested that the provisions of 30 mt. wide green belt along the railway lines and the provision of the RP-2021 of green belt along the railway lines may be waived.

Chief Regional Planner, NCRPB suggested that it relates to amendment in the RP-2021 Similar issues may be listed and sent to the Board alongwith the problem being faced by the States. This would be considered during the review of RP-2021 which is due September, 2010. States could also address such issues in SRP which is under preparation.

After discussion, the Planning Committee decided that such issues could be listed and sent to the Board before the review exercise starts for the consideration of the Review Committee.

The meeting ended with a vote of thanks to the Chair.

# Annexure-3/III

Extracts of relevant examination of land uses analysis given in the Regional Plan-2021 and Section 40 of the NCR Planning Board Act, 1985 by the Hon'ble Allahabad High Court

The provisions of the NCR Planning Board Act, 1985 and the provision of Regional Plan-2021 have been examined by the Hon'ble Court from para 4 of Page 211 of the order onwards.

2. The Hon'ble Court has examined the issues related to the provisions of NCR Planning Board Act, 1985 as well as provisions of the Regional Plan-2021. It has examined the paragraph 17.5 and 17.5.1 (a) of the Regional Plan-2021 (P-180) which provides for Zoning Regulations and is re-produced below (P-231 & 232 of order):

"Keeping in view rapid urbanisation, environmental degradation and to ensure orderly development in the region, a legislative tool in the form of Zoning Regulation is required. In view of this, four broad zones have been identified for application of strict land use control and development and enabling preparation for detailed Plans such as Sub-regional/Master/Local Area Plans. The elaboration of the land use details and zoning regulations would be incorporated in the Sub-regional Plans and Master/Development Plans by the respective State Governments. Four broad zones and major activities/uses permitted in these zones are given below:

#### 17.5.1. Controlled/Development/Regulated Zone

(a) Urbanisable Areas (including existing built-up/urban areas)

Within the urbanisable area proposed in the Master/Development Plan of the respective towns, the functions and uses designated as under be continued:

- i) Residential
- ii) Commercial
- iii) Industrial
- iv) Government offices, public and semi-public
- v) Recreational
- vi) Utility services
- vii) Transport and communications
- viii) Open spaces, parks and playgrounds
- ix) Graveyards/cemeteries and burning ghats
- x) Man-made heritage areas
- xi) Natural heritage areas/eco-sensitive areas/conservation areas

The local authority according to the prescribed uses in the Master/Development Plans will govern detailed land uses within the urbanisable area. The Master/Development Plans of all the towns will be prepared within the framework of the Regional Plan-2021 and Sub-regional Plans. In case any amendment is required in the acts to implement the policies of Regional Plan-2021 that be done by the respective State Governments appropriately."

3. The Hon'ble Court further examined the provisions of Section 40 of the NCR Planning Board Act, 1985 and analyzed the same with reference to the provisions of the Para 17.3.1 of the Regional Plan-2021. The analysis/ examination done by the Hon'ble Court is re-produced below (P-242-243 of Order):

"Section 40 of the NCRPB Act, 1985 provides that Acquisition of land shall be made by the Government of the concerned participating State where necessary to give effect to any Regional Plan, Functional Plan, Sub-Regional Plan or Project Plan.

Section 40 of the NCRPB Act, 1985 has to be interpreted in a manner so as to promote the object of the Act. When the land use in the NCR Region is controlled by various plans as contemplated by the NCRPB Act, 1985 the acquisition of land has also to be in line and conformity with the aforesaid Act, 1985. This can be illustrated by giving a small example i.e. supposing an area in the NCR is reserved for agricultural use and actual agricultural is taking place in the said area, any exercise by the Authority to acquire land for residential purpose shall be simply prohibited. The Authority in the present cases have indiscriminately proceeded to acquire the land in the name of Planned Industrial Development. In event where agriculture is the reserved purpose acquiring the land of the agriculturist shall be with no object since the Authority itself shall not carry on agriculture and there shall be no purpose to create hindrance in the right of the agriculturists to carry on their agriculture in the said area.

At this juncture, it is also to be noted that in the Regional Plan-2021, the NCRP Board has expressed concern and alarm on conversion of agricultural land to other uses indiscriminately. The Board in paragraph 17.3.1. has noticed large scale conversion of agricultural land to non-agricultural land. It is useful to quote paragraph 17.3.1:

"17.3.1. Large-scale Conversion of Agricultural Land to Non-Agricultural Use.

The land use analysis indicates that from 1986 to 1999, the land under agriculture shrank by 8.12% i.e., from 87.64% to 79.52%. This drop of 8.12% is considerable when compared with the proposed drop of only 3.8% (87.64% to 83.84%) stated in Regional Plan - 2001. This has resulted not only into overconversion of agriculture into non-agriculture land but also non-conformity with the proposed settlement pattern of the Regional Plan-2001."

Section 40 of the NCRPB Act, 1985 as noticed above has to be given some meaning and purpose. Section 40 of the Act, 1985 has to be read as a precondition for participating State to acquire the land, condition being that acquisition be made in NCR only to give effect to any regional, functional plan, sub-regional plan or project plan framed under the 1985 Act."

The analysis of the Hon'ble Court indicates that the Court noted the concern of the Board with regard to large scale conversion of Agricultural Land to other uses indiscriminately. In view of this and in view of the comments of the State Government that the draft Master Plan Greater Noida is not in conformity with the Regional Plan-2021 with regard to the density provisions in the draft Plan, it becomes important to examine this aspect in much details as it has got direct bearing on the conversion of Agricultural Land from Agricultural Use to non-Agriculture use.

Kindly refer to letter No.-1942/77-4-11-09 Bha./02 dated 11<sup>th</sup> Nov.2011 of special secretary, Govt. of Uttar Pradesh vide which Greater Noida Master Plan 2021 has been recommended and sent to NCRPB for granting NOC expressing satisfaction with regard to conformity of Greater NOIDA Master Plan 2021 with Regional Plan 2021. In this regard, following facts are being brought to your kind notice:-

1. The Greater Noida Master Plan-2021 was prepared in the year 2001 and sent to the NCRPB for sanction of population and suggestions on Greater Noida Master Plan Area. On the basis of interactions and letters exchanged, Greater Noida was declared Metro Centre with an assignment of 12.0 lacs population in the National Capital Regional Plan-2021. The area distribution chart showing the land use breakup of Greater Noida Master Plan-2021 is as follows:

- Subsequently the Greater Noida Master Plan-2021 was presented in the 54<sup>th</sup> Plan Committee meeting of NCRPB. In total 11 observations/ suggestions were made by the Plan Committee. The suggestions were incorporated in the Greater Noida Master Plan-2021 and the revised Master Plan incorporating the suggestions was sent to NCRPB vide letter no. niyojan/m-1(iv)/2007/479 dated 2/2/2007. (copy enclosed).
- 3. Three observations/ suggestions were again made by NCRPB vide letter no.K-14011/66/2001-NCRPB dated 9.5.2007 which was replied vide letter dated 27July, 2007. (copy enclosed).
- 4. Vide notification dated 14.06. 2006 of Govt. of U.P. 188 more villages were notified in the development area of Greater Noida.
- 5. NCRPB, vide it's letter dated 13.05.2009 requested Greater NOIDA Authority regarding preparation of Master Plan for the extended area of the Greater Noida which was replied by CEO, Greater NOIDA's letter dated 11.06.2009. (copy enclosed).
- 6. The Master Plan for Greater Noida including the expanded area has been prepared and submitted to U.P. Government for approval. This Master Plan for a total area of 864 hectares will be master Plan for 2031. The updated plan of extended area has been incorporated in the sub-regional plan of UP NCR region.

It is also to bring to your kind notice that Hon'ble High Court of Allahabad in it's order dated 21.10.2011 has directed Greater Noida Authority to seek satisfaction of NCRPB w.r.t incorporation of suggestions/observations of NCRPB in the Master Plan 2021of Greater Noida.

Section 19 of the NCRPB Act 1985 mandates submission of <u>Sub-Regional Plan</u> of the participating state (not the Master Plan of the individual City/ Notified area of the Authority) to the NCRPB to ensure conformity with the Regional Plan, but in view of the Hon'ble court's order Master Plan 2021 of Greater Noida incorporating all the changes suggested by the NCRPB and further developments taken place in the region e.g. the DMIC Project, DFC Corridor and a number of expressways originating from the area, is enclosed with the letter for kind consideration

As you are aware that under the direction of Industrial Development Section 4 vide letter No.3147/77-4-6-9 Bha/02, dated 15.06.2006, the Chief Coordinator Planner, NCR Cell, U.P., Ghaziabad vide his letter No.2231/Gr. Noida Maha-2021/NCR/2006-07, dated 28.06.2006 has submitted the draft Master Pla -2021 for Greater Noida to the NCR Planning Board for approval. The draft Master Plan-2021 for Greater Noida was examined and further discussed with the General Manager, (Planning & Architecture), Greater Noida Authority in the chamber of Chief Regional Planner, NCRPB and revised document was received from Greater Noida vide letter No.Plg/NCR/2006/291/M-1, dated 28.08.2006. The revised Plan document was examined and placed before the 54th Planning Committee meeting held on 4.9.2006. The Planning Committee examined the draft Plan and offered observations & suggestions which were sent to the Greater Noida Authority for incorporation. A copy of the Minutes of the meeting is enclosed.

Subsequently, the Greater Noida Authority vide letter No.Niyojan/M-1(iv)/2007/479, dated 2.2.2007 has intimated that they have incorporated most of the observations & suggestions of the Planning Committee. Board has examined the matter and it was observed that some of the observations have not been incorporated. The Planning Committee observed that the Government of U.P. is proposing to develop Greater Noida Phase-II adjacent to present Greater Noida notified area. It was suggested that a provision of green buffer of about 5 kms. width may be kept along the boundaries of the notified area of Greater Noida and Greater Noida Phase-II. In response the Consider Monda Authority stated that a green best will be provided in Phase-II plan. It was decaded that both the Plans i.e. Greater Norda Phase-I and Greater Norda Phase-II will be taken together to the Planting Communice for consideration.

If we compare Industrial use it is about 4.88% higher than the guideline; if we compare institutional, it is as per guideline; if we compare transportation, it is almost same as guidelines and in case of green areas which includes recreational also, it is within the proposed limits of the guidelines.

The Master Plan for Greater Noida-2021 has been prepared for a population of 12.00 lakhs for a gross urbansiable area of 22255 ha. by 2021. Broad Salient Features of the Plan are as follows:

#### i) Landuse

The details of the land uses given below:

## ii) City level population density

The city level population density on the gross area 22255 ha. works out to about 54 persons/ha.

## iii) Transport

Major road linkages planned are:-

- a) From Delhi and NOIDA Access via DND Flyway Toll Bridge to NOIDA-Greater NOIDA Expressway, which is proposed to be extended up to Agra (Yamuna Expressway).
- b) Link from NOIDA via Okhla Barrage road through the Master Plan road Nos of NOIDA, extending it across river Hindon and providing access to the 130.0m wide road of Greater Noida.
- c) Link from Easter peripheral Expressway of NCR Plan at NH-24 interchange.
- d) Link from NH-24 to connect area on north of Entry road.
- e) Link to surrounding areas of Uttar Pradesh shall be via NH-24 bypass in the northern side and from GT Road on eastern side of the area.
- f) A 130m. wide road has been planned as backbone of the linear city for connecting its northern and southern parts and also NOIDA and Delhi.

### Rail Linkages

- a) Boraki is proposed to be developed as a new railway station on the northern railway main line. A feasibility report for the same has been prepared by RITES and submitted to Railways.
- b) A rail link between Dadri and Tuglakabad is proposed, which will connect Greater NOIDA with the main railway lines in the east to Calcutta and west to Bombay.
- c) For movement of goods traffic Inland Container Deport has been located, which will be provided with rail linkage form Tuglakabad.
- d) There is proposal to have Transport hub at Boraki, which shall provide comprehensive facilities for integrate of passenger railway station, ISBT, Truck Terminal. Etc.

#### Mass Rapid Transit System

A feasibility study has been carried out by RITES for developing a rail transit system between NOIDA and Greater NOIDA also serving the city of Greater NOIDA. Based on the results of transport demand forecast and system selection, a light Rail Transit (LRT) system has been recommended.

Phase-I:

NOIDA City Centre to GNIDA along Strom Drain, proposed SEZ, Gautam Buddha

Expressway, Pari Chowk and along 105m road upto proposed 130m road (about 29 km).

Phase-2:

GNIDA to NOIDA City Centre - Along 130m. middle spine road, NOIDA Sec.52 9about

25km)

## iv) Water supply

Water requirement for 12.0 lakhs population is envisaged as 350 MLD. Water requirement projected for area under Phase-I(2001) is 80 MLD, Phase-II (2011) is 74 MLD and Phase-III (2021) is 197 MLD.

Source of water supply is from tubewells tapping underground water. Ultimately a perennial source of water will be Ganga Water from Upper Ganga Canal. 85 cusec Ganga Water has aheading been allotted to GNIDA by UP Govt. The project has been taken up by UP Jal Nigam. A detailed Water Supply Master Plan 2021 has been prepared.

## v) Sewerage

The total sewage generation is estimated as 193 MLD for 12.0 lakh population. Of this, the generation for Phase-I (upto 2001) is 57 MLD, for phase-II (upto 2001-2011) is 48 MLD and Phase-III (upto 2011-2021) is 88 MLD.

A sewage treatment plant of 105 MLD is proposed near village Kasna for Phase-I and Phase-II scheme. 44 MLD STP (2 nos.) will be provide for Phase-III near Lohia Lake and Dasna drain. A detailed sewage Master Plan has been prepared.

## vi) Storm water drainage

The Master Plan for Storm Water has been prepared. In the area proposed for phase-I and II, the ground is sloping from North-east to South-west, therefore the drainage net work is proposed from North-east to South-west direction and all drains are connected with the existing Hawalia drain which is ultimately discharging into River Hindon. Drainage of Phase-III area is proposed to be discharged in Dasna drain and Hawalia drain through Lohiya lake.

## vi) Rainwater Harvesting

In the Master Plan 2021 about 25% area has been planned under green area. In green areas, though water is recharged naturally, Greater Noida has also made suitable recharge pits. At household level Rainwater harvesting has been made mandatory for plots having an area more than 100 m<sup>2</sup>. A detailed guidelines have been prepared for Rainwater Harvesting.

#### vii) Solid Waste

GNIDA has already identified a site at village Amarpur for treatment and disposal of MSW. A study is being taken up to assess the suitability of the pre-identified site for the development of the composting plant and the landfill facility.

#### viii) Power

The requirement of power in Greater Noida shall be met through following options:

- a) From 1800 MW capacity Dadri Thermal Power House of NTPC. A 400 KV Double circuit Dadri Ballabgarh power grid line is passing from Greater Noida. Proposed 400 KV Substation in Greater Noida shall be connected to this line.
- b) From proposed power generating station of 3500 MW capacity of Reliance Energy near Dadri.
- c) From State Transmission Grid of UP Power Corporation Ltd.

### ix) Natural Heritage

GNIDA is endowed with rich natural heritage sites which need to be developed as conservation areas. Policies and strategies for conservation of sites and biodiversity shall be detailed oout in the Conservation Master Plan. Primarily important natural sites planned to be conserved are-

Protected forest area nearly 1015 ha. protected forest areas falls within the notified area of Greater Noida.

## x) Disaster Management Plan (DMP)

Disaster Management (DMP) is being prepared for the city and the National Institute of Disaster Management (NIDM) has been assigned the task to prepare a comprehensive and holistic plan covering the residential, commercial, industrial and other areas of the township. An MoU has been signed with NIDM for the study.

After discussions, it was decided that participating States would expedite delineation of Counter-Magnet Area/Counter-Magnet Area Corridor if not done so far and prepare Master/Development Plan, Plan of Action for its implementation and project for development.

## AGENDA ITEM NO.4: STATUS OF PREPARATION OF SUB-REGIONAL PLANS

Director General, Town & Country Planning Department, Govt. of Haryana informed that the draft final Sub-Regional Plan for Haryana Sub-Region is being revised in the light of the observations and suggestions of the NCR Planning Board. The Plan perspective year is also being revised from 2021 to 2031 and the revised draft final Sub-Regional Plan for Haryana Sub-Region will be submitted to the NCR Planning Board within a month.

- 2. Chairperson observed that the progress of preparation of Sub-Regional Plan for Rajasthan Sub-Region is slow. Chief Town Planner, NCR, Town & Country Planning Department, Govt. of Rajasthan informed that the Interim Report-I was approved by the CRC. He further informed that on Interim Report-II, observations and suggestions are to be incorporated by the Consultant.
- 3. The representative from DDA informed that the inter-state connectivity agreed upon by the Govt. of NCT-Delhi have been incorporated in Zonal Development Plans. Regarding other inter-state issues, the adjoining States may take up the matter with GNCT-Delhi / DDA. The issues regarding addendum can be examined as part of the ongoing review of MPD-2021.

Chairperson suggested that the concerned State Government and NCRPB officers may be invited for UTTIPEC meeting when the proposals related to inter-state connectivity are discussed. A formal letter may be issued to the Hon'ble Lt. Governor of Delhi and Chairperson of UTTIPEC for inclusion of representatives of adjoining States whenever inter-state connectivity issues are taken up.

- 4. Chief Regional Planner, NCRPB informed that Board has received the Draft Sub-Regional Plan for UP Sub-Region-2021/31 on 1.2.2012. After examination by the Board Secretariat, observations and suggestions were sent to the Govt. of UP on 14.3.2012 with the request to incorporate the observations and suggestions and submit the revised draft Sub-Regional Plan for UP Sub-Region-2021/31 to the NCR Planning Board for placing the same before the Planning Committee for consideration. Representatives from Govt. of Haryana and Rajasthan requested to provide them a copy of observations on Sub-Regional Plan for UP Sub-Region so that they may address to common issues in preparation of their respective Sub-Regional Plans.
- 5. After discussions and deliberations it was decided that NCR participating States will expedite the preparation of Sub-Regional Plans for their respective Sub-regions. A copy of the observations on the Sub-Regional Plan for UP Sub-Region may be sent to Govt. of Haryana and Rajasthan.

- iii) The Work Programme / Action Plan for the Cells during 12<sup>th</sup> Plan period may be placed before the Board.
