

GNCT-Delhi informed that since planning is the mandate given to DDA in Delhi, GNCTD would request DDA to include these items also in the Master Plan 2021 for Delhi so that it could qualify for Sub-Regional Plan for Delhi. It was decided in 59th meeting of the Planning Committee of NCRPB that the issues regarding addendum can be examined as part of the on-going review of MPD-2021. Board in its 32<sup>nd</sup> Meeting held on 22.3.2012, while reviewing the status directed DDA to expedite the preparation of Addendum to the MPD-2021. However, Management Action Group (MAG) for Review of MPD-2021 in its meeting held on 10.09.2012 under the Chairmanship of Chief Secretary, GNCT-Delhi decided that GNCT-Delhi will prepare Sub Regional Pan for Delhi Sub-region.

The representative from Govt. of NCT-Delhi will give the present status.

## AGENDA ITEM NO.3: CONSIDERATION OF DRAFT REVISED REGIONAL PLAN 2021 FOR NCR

- 3.1 The NCR Planning Board had prepared the Regional Plan 2021 with the active participation of the NCR constituent States of Haryana, Rajasthan, Uttar Pradesh and NCT-Delhi, and the Central Ministries concerned. The Regional Plan 2021 was approved by the Board in its 28th meeting held on 09.07.05 and notified in the Gazette of India under Section 13 of NCRPB Act, 1985 and Rule 27 of NCRPB Act, 1985 on 17.9.2005.
- 3.2 As per provisions of the Section 15 of the NCR Planning Board Act, 1985, Regional Plan is required to be reviewed after every five years from the date of its operation.
- 3.3 Board has initiated review and revision exercise for the Regional Plan 2021 as per provisions of the NCR Planning Board Act, 1985. A Steering Committee under the Chairpersonship of Member Secretary, NCR Planning Board was constituted on 17.07.2012 to oversee the work of review of the Plan. Study Groups were formed for the review and revision exercise of Regional Plan 2021 for NCR.
- Three Chapters on Water, Transport and Environment were discussed and deliberated in the Workshops with the stakeholders held on 21.11.2012 26.11.2012 and 07.02.2013 respectively. The recommendations of the Workshops and comments and suggestion received have been incorporated in the modified Chapter on Water, Transport and Environment. In the third meeting of the Steering Committee meeting held on 20.04.2013, Chapters 1,2,3,4,6,8,9,14 and 15 of Regional Plan-2021 were discussed. Subsequently, comments and suggestions received from NCR Cell, U.P. vide letter dated 18.04.2013 were incorporated in the concerned Chapters.
- 3.5 In the fourth meeting of the Steering Committee held on 16.5.2013, the Draft Revised Regional Plan 2021 for NCR containing all the Chapters was deliberated. The Draft Revised Regional Plan-2021was discussed in the Workshop on Review and Revision of Regional Plan-2021 for NCR held on 28.05.2013 with the concerned Central Ministries and the NCR participating States and other Stakeholders. Some of the observations and suggestions have been incorporated in the Draft Revised Regional Plan-2021 and placed at Annexure-3/1.

#### Action Point:

The Draft Revised Regional Plan-2021 for NCR is placed before the Planning Committee for consideration. The recommendations of the Planning Committee will be placed before the Board for approval for inviting objections/suggestions from the public under section12 (1) of the NCRPB Act, 1985.

### AGENDA ITEM NO.4: CONSIDERATION OF SUB-REGIONAL PLAN FOR UP SUB-REGION 2021

- 4.1 Under Section 17(1) of the NCRPB Act, 1985 "Each participating State shall prepare a Sub-Regional Plan for the sub-region within that State and the Union Territory shall prepare a Sub-Regional Plan for the sub-region within the Union territory".
- 4.2 In the 29th Meeting of the Board held on 24.05.2006, the representatives of the Constituent States were requested to prepare the Sub-Regional Plans of their respective Sub-regions.
- 4.3 The Housing & Urban Planning Department, Govt. of U.P. vide letter No. 338/8-3-2012-272 /11 dated 31.01.2012 had submitted the Draft Sub-Regional Plan for U.P. Sub-Region-2021/31 to NCR Planning Board. After examination, Board vide letter No. K-14011/109/2006- Vol. III dated 14.03.2012 sent its observations to Govt. of U.P. for incorporation in the Draft Sub-Regional Plan for U.P. Sub-Region-2021/31.
- 4.4 Incorporating Board's comments and suggestions, Govt. of U.P. has submitted the amended Draft Sub-Regional Plan for U.P. Sub-Region-2021 vide letter No.Bha.Sa.22/8-3-13-272 Vividth/11 T.C.II dated 29.03.2013. The revised Draft Sub-Regional Plan for U.P. Sub-Region-2021 was examined by the Board and comments and observations of Board's Secretariat were sent vide letter No. K-14011/109/2006- Vol.-V dated 02.05.2013 to Govt. of U.P. for incorporation.
- 4.5 The Govt. of Uttar Pradesh vide letter No.1005(1)/8-3-13-272 Vividth/11 T.C.II dated 22.05.2013 submitted the amended UP Sub-Regional Plan-2021 along with the comments of the Govt. of UP on the NCRPB's observations / suggestions on the amended Sub-Regional Plan for UP Sub-Region-2021 placed at Annexure-4/II. The observations / suggestions which have not been incorporated in the Sub-Regional Plan along with the NCRPB's observations/ suggestions are at Annexure-4/II. A CD containing the amended draft UP Sub-Regional Plan-2021 is enclosed.

#### **Action Point**

Draft Sub-Regional Plan for U.P. Sub-Regional-2021 and Annexure-4/II are placed before the Planning Committee for consideration. The Draft Sub-Regional Plan for U.P. Sub-Region along with the recommendations of the Planning Committee will be placed before the Board for consideration and approval.

AGENDA ITEM NO.5: CONSIDERATION OF PROPOSAL OF INCLUSION OF ADDITIONAL AREA IN NCR AND IDENTIFICATION OF JAIPUR AS COUNTER MAGNET AREA.

5.1 Proposal of inclusion of Additional Area in NCR.

#### Rajasthan

Board has received the proposal for inclusion of **Bharatpur** district in NCR from Government of Rajasthan vide letter no. TPR/NCR/BHARATPUR/11/30 dated 12.01.2012 is placed at **Annexure-5/I.** In the proposal following potentials of Bharatpur District have been stated:

• Bharatpur is 175 Km from Delhi.

• Bharatpur district is part of Golden triangle Delhi – Agra – Jaipur.

• Tourism as main revenue generating activity (Ghana bird Sanctuary)

Historical and religious place.

• Availability of skilled labour due to the number of technical institutes.

Connectivity by road (NH and SH) and rail Delhi - Mumbai and Agra - Jaipur.

Bharatpur is agriculture area.

• Three rivers flows through Bharatpur district providing water for irrigation and other activities.

The following justifications for inclusion of Bharatpur in NCR have also been given:

• It is in contiguity with Alwar district of NCR.

e It would help in achieving a balanced and harmonious development of NCR.

• It is a part of the proposed Bharatpur - Kota Development Corridor.

• It would help in dispersal of economic activities and absorbing future inmigrants to Delhi.

#### Haryana

2. Board has received request for inclusion of **Mahendragarh** and **Bhiwani** districts of Haryana in NCR jointly from Shri Rao Dan Singh, Chief Parliamentary Secretary; Shri Satpal Sangwan, Cooperation Minister and Shri Rao Narender Singh, Health Minister, Haryana vide letter no. Nil dated 15.06.2012 addressed to Hon'ble Minister for Urban Development from Ministry of Urban Development is placed at Annexure-5/II.

Subsequently, Board has received a request vide D.O. letter no. PHED/428/2012 dated 05.07.2012 from Smt. Kiran Chaudhary, Public Health Engineering, Excise & Taxation Minister, Govt. of Haryana addressed to Hon'ble Minister for Urban Development for inclusion of Bhiwani and Narnual Towns of Haryana in NCR is placed at Annexure-5/III. In the above mentioned letter following have been mentioned:

- People of these districts are facing scarcity of potable and drinking water.
- Lack of educational institutions are hampering the growth of these districts.
- Due to paucity of funds and improper planning the area lacks in progress and development.
- Central university has been setup in Mahendragarh district.
- Extension of the NCR limit would ease the congestion in the NCR.

Subsequently, facts relating to inclusion of Mahendragarh and Bhiwani districts of Haryana in NCR provided by the NCR Cell, Haryana are as under:

Board vide letter no. D-25011/6/2012-VIP Ref. dated 08.08.2012 (Annexure-5/IV) has requested the Financial Commissioner and Principal Secretary, Town & Country Planning Department, Govt. of Haryana nodal officer for NCR for their views and comments so that matter can be considered by the Study Group for review and revision of Regional Plan-2021. Subsequently, Board vide D.O. letter No. K-14011/56/2012-NCRPB dated 03.09.2012 (Annexure-5/V) again requested for views and comments and also requested for a presentation before the Study Group meeting. Board has not received views and comments in response to our letter dated mentioned above. However, a presentation was made before the third meeting of the Study Group-I held on 27.09.2012.

#### Uttar Pradesh

3. Board has received request for inclusion of Mathura-Vrindavan of Mathura District in NCR from Shri Pradeep Mathur, MLA vide letter no. Nil dated 24.03.2012 addressed to Hon'ble Minister for Urban Development from Ministry

of Urban Development is placed Annexure-5/VI. In the proposal following have been mentioned:

- Mathura is 140 Km from Delhi.
- Trains from Southern, Central and Western railways pass through Mathura.
- Daily about 15 to 20 thousand commute to work in Delhi.
- Mathura being the place of Lord Krishna is a famous historical and religious city, places of interest like Govardhan, Vrindavan, Barsana, etc. are located in Mathura.
- Mathura is very well connected with Yamuna expressway.
- Project of industrial area of 1000 acres based on CNG, PNG and Industrial Gas is sanctioned by Petroleum Ministry.

Board vide letter no. D-25011/6/2012-VIP Ref. dated 09.07.2012 had requested Principal Secretary, Town & Country Planning Department, Govt. of Uttar Pradesh for their views and comments. Subsequently, Board vide D.O. letter No. K-14011/56/2012-NCRPB dated 03.09.12 again requested for views and comments and also requested for a presentation before the Study Group meeting. In response, Govt. of UP vide letter no. मार्गार 272-12-3-8/55 विविध/ 11टी.सी. dated 26.09.2012 intimated that if Mathura district is included, for maintaining the contiguity two districts namely Aligarh and Mahamaya Nagar need to be included in NCR and requested that this may be examined by the Study Group constituted for review and revision Regional Plan-2021 is placed at Annexure-5/VII.

#### Proposal

4. The total area proposed for inclusion in NCR is 15434 Sq Km. Details are given below:

Note: \* Area of 15434 sq.km. excluding Aligarh and Mahamaya District. Contiguity can be maintained by adding Aligarh district.

The map showing the proposed additional area is at Appendix-I.

5. It was observed that if the proposed areas of Mahendragarh and Bhiwani districts in Haryana, Bharatpur district in Rajasthan and Mathura district in U.P are included then the notified area of NCR would be increased by 57% (from 33578 Sq Km to 49012 Sq Km). In case of Govt. of U.P no specific recommendation for inclusion of Mathura district in NCR was received in the Board. However Govt. of U.P has suggested to include Aligarh district if Mathura district is included for contiguity of NCR boundary.

- vi) The matter was discussed in the Study Group-I: NCR Policy Zones, Demographic Profile, Settlement Pattern, Regional Landuse and Rural Development constituted for review and revision of Regional Plan-2021 meeting held on 11.04.2013 and following decisions were taken:
  - a) Any additional area should be added after carrying out delineation Study based on certain criteria like population growth rate, migration, density, economic activity, traffic movement and service level bench mark.
  - b) Delineation study for the NCR may be initiated immediately and a Committee may be constituted by the Board to decide about the criteria and Terms of Reference.
  - c) The inclusion of additional area will lead to spreading of scarce financial resources thinly.
- vii) A similar "Delineation Study of the National Capital Region" was conducted by Town & Country Planning Organisation, Government of India in 1967 when NCR was originally delineated.
- viii) The recommendations of the Study Group-I was discussed in the fourth meeting of the Steering Committee constituted for review and revision of Regional Plan-2021 held on 16.05.2013. The Steering Committee considered the recommendations of the Study Group and suggested that the delineation Study should be conducted.

#### 5.2. Proposal for identification of Jaipur as a Counter Magnet Area.

Government of Rajasthan submitted a proposal for identification of Jaipur as Counter Magnet Area to NCR vide letter no. टीपीआरएन/.सी.आर/सीएमए/11/363 dated 20.03.2012 is placed at **Annexure-5/VIII**.

#### Justifications given by the State Government are as under.

- Population 36.47 lakh (as per Census 2011)
- Capital of Rajasthan State

- Distance 250 Km from Delhi
- 120 Km from NCR border
- Important tourist place
- Low property rates and life style attracts investors and tourists
- Scope for Rural Tourism
- Increased investment in various sectors
  - a) Development of SEZ
- b) Development of educational and knowledge industry Proposals by government in Jaipur to upgrade the city
  - Development of Ring road (360 m wide)

- MRTS
- Grain market
- Handicrafts
- Small scale Industries


Location map of Jaipur is at Appendix-II.

The proposal was deliberated in the Study Group-I meeting held on 28.01.2013. The Study Group observed that since the migration data for Census 2011 is not yet available, it is not possible to examine the proposal and also decided that it would be appropriate to examine Jaipur along with other areas such as Chandigarh before any decision on additional Counter Magnet Area in taken after the migration date for Census 2011 is available.

The recommendations of the Study Group were deliberated in the fourth Steering Committee meeting held on 16.05.2013 wherein it was decided that the proposal of identification of Jaipur along with other areas such as Chandigarh as counter magnet area will be examined after the migration data for Census 2011 is available.





## NATIONAL CAPITAL REGION COUNTER-MAGNET TOWNS



## AGENDA ITEM NO.1: CONFIRMATION OF THE MINUTES OF THE 59<sup>TH</sup> MEETING OF THE PLANNING COMMITTEE HELD ON 16.03.2012

Minutes of the 59<sup>th</sup> meeting of the Planning Committee held on 16.03.2012 were circulated vide letter No. K-14011/14/2012-NCRPB dated 20.03.2012. No comments have been received. The minutes were confirmed.

## AGENDA ITEM NO.2: ACTION TAKEN REPORT ON THE DECISIONS OF THE 59<sup>TH</sup> MEETING OF THE PLANNING COMMITTEE HELD ON 16.03.2012

Action Taken Report on the issues/decisions taken in the last meeting were reviewed.

#### i) Development of Highway Corridor Zones

The Planning Committee noted the status. It was decided that NCR Participating state will send the detailed status on delineation of Highway Corridor Zones and preparation of Master / Development Plans of towns in NCR to the NCRPB.

[Action: All NCR participating State Govts./ NCR Cells]

#### ii) Functional Plan for Ground Water Recharge

The Planning Committee noted.

iii) Functioning of the existing STPS and CETPS and Work Plan to bring it to desirable standards/sanitation Master Plans.

The Planning Committee noted that data received from CPCB for CETPs has been circulated to NCR participating states.

#### iv) Solid Waste Management in NCR

Planning Committee directed the participating States to send the Solid Waste Management Plan and Action Plan to NCRPB at the earliest.

[Action: All NCR participating State Govts./ NCR Cells]

#### v) Review of Status of for Development of CMA's

Planning Committee decided that the participating States would expedite delineation and declarations of Counter-Magnet Areas/ Counter-Magnet Area Corridor and prepare Master/Development Plan, Plan of Action for its implementation and project proposals for funding. Latest status may be sent to the NCRPB.

[Action: All NCR participating State Govts./ NCR Cells]

#### vi) Draft Master Plan for Greater Noida-2021

This item has been discussed as Agenda item No.3:

#### vii) Status of preparation of Sub-Regional Plans

Planning Committee noted that NCRPB had sent its observations/ suggestions on the draft Sub-Regional Plans for UP Sub-region.

The Committee directed the participating States to expedite the preparation/finalization of Sub-Regional Plans.

[Action: All NCR participating State Govts./ NCR Cells]

viii) Approval for continuation of the NCR Planning & Monitoring Cells in the participating States and NCT Delhi during the 12<sup>th</sup> Five Year Plan Period

Planning Committee noted that Board has communicated the approval of the continuance of the NCR Planning & Monitoring Cells during XII Plan to the participating States with the following conditions:

- a) The Action Plan for filling up the vacant posts may be submitted to the Board's secretariat and State Govt's to ensure filling up these posts at the earliest.
- b) The staff strength of all NCR Planning and Monitoring Cells is proposed to be continued for 12<sup>th</sup> Plan period as per 11th Plan period. The NCRPB shall continue to reimburse 100% of expenditure on pay & allowances and recurring office expenditure for NCR Cell, Haryana, Rajasthan, UP and Delhi upto the ceiling prescribed for XI Plan period;

c) The Work Programme / Action Plan for the Cells during 12<sup>th</sup> Plan period may be placed before the Board.

The Committee directed that participating States should expedite the filling up of vacant posts and Year Wise Work Programme for the NCR Cells during the 12<sup>th</sup> Plan period may be submitted immediately.

## AGENDA ITEM NO.3: CONSIDERATION OF DRAFT MASTER PLAN FOR GREATER NOIDA -2021

Planning Committee deliberated on the observations / suggestions made in the 54<sup>th</sup> meeting of the Planning Committee held on 4.9.2006 which were communicated to GNIDA/Govt. of UP vide letter no 14011/100/2006-NCRPB dated 14.9.2006. Response was received from Govt. of UP on all observations vide letter no 5857/8-3-2011-294 vivid/11 dated 14.12.2011.

#### Issues/Observations/Suggestions

i) A green buffer of about two km. width should be kept between the urbanisable areas of Noida and Greater Noida along the Hindon River.

#### Deliberations & Decision of the Planning Committee

CEO, Greater Noida informed that green buffer of about two km. width has been kept between the urbanisable areas of Noida and Greater Noida along the Hindon River, in the newly planned area.

Planning Committee considered and found that the concern had been addressed.

#### Issues/Observations/Suggestions

ii) While preparing the detailed plans, a green buffer of suitable width between industrial area and the residential areas on the northern side of the proposed Greater Noida Land Use Plan should be kept to act as a barrier for pollution. Suitable areas should be earmarked for IT industries in this industrial zone.

#### Deliberations & Decision of the Planning Committee

CEO, Greater Noida informed the Planning Committee that while preparing the detailed plans of residential and industrial areas, a green belt has been left as a principle of planning along the Master Plan roads. In the northern side adequate green buffer has been provided while planning industrial sectors along the proposed residential sectors. IT industries are permissible within industrial areas and specific area is already earmarked for IT industry in the Master Plan. He added that in future more area shall be earmarked while doing the detailed planning based on demand for IT industry.

Planning Committee considered and agreed.

#### Issues/Observations/Suggestions

iii) Land / plots for smaller industrial units should be earmarked where the smaller units may be relocated.

#### Deliberations & Decision of the Planning Committee

CEO, Greater Noida informed that Land / plots for smaller industrial units required for 250 sqm to 500 sqm have been earmarked at Ecotech-III and Ecotech-III for relocating smaller industrial units.

Planning Committee considered and agreed.

#### Issues/Observations/Suggestions

iv) The area between the railway line and the GT road has been kept as agriculture land outside the notified area which may be prone for unauthorized constructions. It was suggested that the areas between railway line and the GT road may be notified and kept as an agricultural green belt.

#### Deliberations & Decision of the Planning Committee

CEO, Greater Noida informed that as per the modified Master Plan-2021 submitted to the Board on 18.5.2012, this area is not part of the Master Plan 2021. Planning Committee considered and agreed.

#### Issues/Observations/Suggestions

v) In the southern part, a large chunk of land has been earmarked as 'industrial' bordering the residential sectors. It was suggested that a green belt of suitable width may be kept to act as a barrier for pollution.

#### Deliberations & Decision of the Planning Committee

General Manager, Greater Noida informed that Kot escape drain passes between the residential and industrial sector is southern part of the city and green belt of 20 mt. width has already been provided while preparing the detailed layout plan of the areas.

Planning Committee considered and agreed.

#### Issues/Observations/Suggestions

vi) Orbital Railway Corridor proposed in the Regional Plan 2021 and Eastern Peripheral Expressway (EPE) to be incorporated in the Greater Noida Master Plan and alignment of the same may be marked on the proposed land use plan. In the Regional Plan 2021, it is proposed that the alignment of the Orbital Rail will be parallel to Peripheral Expressway.

#### Deliberations & Decision of the Planning Committee

CEO, Greater Noida stated that the alignment of Eastern Peripheral Expressway as received from the NHAI has been incorporated. The orbital rail corridor has been kept parallel to Eastern Peripheral Expressway.

Planning Committee observed that the Orbital Rail Corridor and Eastern Peripheral Expressway (EPE) have been incorporated in the Master Plan and therefore Planning Committee agreed.

#### Issues/Observations/Suggestions

vii) It was suggested that BRT system may be adopted for smooth intra city traffic movement. The cross section of the proposed road including the BRT system need to be provided for all categories i.e. expressway, arterial, sub-arterial of roads. It was also suggested that suitable provision may be kept for non-motorised transport (NPT) and slow motorized traffic (SMT) in the Master Plan.

This issue was discussed in S.No.3 Para (iv) of comments and observations of the 59th Planning Committee.

#### Issues/Observations/Suggestions

viii) Since Greater Noida is being planned for the hi-tech housing/residential, it would be appropriate that suitable areas may be earmarked for the EWS and LIG categories as well as Group Housing Societies in the residential sectors of the Master Plan of Greater Noida and suitable percentages of residential areas should mentioned in the written document of the Master Plan for EWS/LIG/ Labour Housing and Group Housing Societies.

This issue was discussed in S.No.2 of comments and observations of the 59th Planning Committee.

#### Issues/Observations/Suggestions

ix) In the Master Plan activities such a bus terminal, LRT Terminal, Multiplex/Cinema Halls etc. are permitted in recreational green areas. The Planning Committee suggested that bus terminal, LRT terminal, to be shown as transport use and Cinema/Multiplex halls to be shown as commercial use and kept out of the greens. However, limited, specific recreational activities related to sports/physical fitness can be incorporated.

#### Deliberations & Decision of the Planning Committee

CEO, GNIDA informed that necessary amendment has been done in the Zoning regulations..

Planning Committee considered and agreed.

#### Issues/Observations/Suggestions

x) It was suggested that a negative list of industries (non-permitted) in the Greater Noida may be prepared and enclosed in the Greater Noida Master Plan document.

#### Deliberations & Decision of the Planning Committee

CEO, GNIDA informed that negative list of industries (not permitted) in the Greater Noida area has been made a part of the Master Plan document.

Planning Committee considered and agreed.

#### Issues/Observations/Suggestions

xi) The Planning Committee observed that the Govt. of UP is proposing to develop Greater Noida Phase II adjacent to present Greater Noida notified area. It was suggested that a provision of green buffer of about 5 km width may be kept along the boundaries of the notified area of Greater Noida and Greater Noida Phase II.

#### Deliberations & Decision of the Planning Committee

CEO, GNIDA/Govt. of UP has intimated vide letter No. Planning/2009/M-1(V)/8608 dated 11.06.2009 that Greater Noida is being developed as a single entity and there is no Phase-II.

CEO, GNIDA stated that though Greater Noida had agreed for provision of green buffer between Greater Noida Phase-I and Greater Noida Phase-II earlier, but now since the Master Plan has been prepared for a single entity, 5 km wide green belt is not feasible. The reasons (which have already been submitted in writing) for not providing the green buffer of 5 km width were reiterated:

- a) Since Western and Eastern dedicated freight corridor starts from the region, the area will become an area of economic activity in respect of multimodal logistic hub, freight container depot, railway station and other related activities.
- b) Existing Industries are already located.
- c) If a 5 km wide green buffer is left the area will become prone to encroachments.
- d) In case acquisition of land for 5 km width green buffer is done it will be make the GNIDA financially unviable.
- e) In the Greater Noida Master Plan 2021 adequate provision for green buffer has already been provided and 16 % land use has been reserved for Green areas which includes three reserved forest areas. A total 3850 Hectares out of 22255 ha. area has been reserved as green area land use.
- f) There is no provision of 5 km width of Green buffer between the towns in the RP-2021 and there is no legal sanctity to provide such green buffer.

Director General, Town & Country Planning Department, Govt. of Haryana stated that there is no statutory provision for 5 km of green belt between the two urban areas in the RP-2021. Also this is not cost effective as the cost of provision of infrastructure increases substantially.

Chief Town Planner (NCR), Rajasthan expressed strong reservation for 5 km wide green belt as it would not only be difficult to maintain as a green but will be under constant pressure of encroachment.

The representative from HUDCO also reiterated that green buffer should be provided at the periphery of urban area and not between two urban areas.

CEO, GNIDA informed the Planning Committee that overall statutory provision of green area of 16% has been provided.

Additional Secretary (UD), Ministry of Urban Development, Govt. of India stated that statutory provision of green area is to be maintained as public green and no change of landuse should be allowed.

Chairperson stated that the decision of providing 5 km green buffer was taken in the 54<sup>th</sup> Planning Committee meeting keeping in view that Greater Noida was planned as Phase-I and Phase-II as two separate entities. But now as informed by CEO, Greater Noida that it is a single entity as indicated by CEO, Greater Noida/Govt. of UP during the meeting, the Planning Committee may like to discuss and reconsider the decision.

After discussions and deliberations, the Planning Committee decided that Govt. of UP/ GNIDA had provided adequate justification for not providing 5 km wide green belt between Phase-I and Phase-II. However, the minimum requirement of 16% green area should not be compromised in the Modified Master Plan for Greater Noida-2021.

Planning Committee then deliberated on the observations and suggestions made on the modified draft Greater Noida Master Plan in the 59<sup>th</sup> Planning Committee.

Issue: Density

The RP-2021 has recommended town level density norms of 150-200 pph for a town with population range 10 lakhs to 50 lakhs whereas the town level density works out to 54 pph for Greater Noida as per the draft Master Plan for Greater Noida -2021 now submitted which is lower than the density norms of RP-2021.

CEO, Greater Noida/Govt. of UP stated that this town is an industrial town and density of an industrial town cannot be compared with a normal town. Therefore, it is difficult to achieve the prescribed density norms as laid down in the RP-2021 for Metro towns. He stated that however, they have been making efforts to increase the city level density and some of the alternatives have been examined and are being presented.

Planning Committee discussed and deliberated various alternatives of development with reference to population density and possibilities for achieving the targeted population of Greater Noida as per Regional Plan-2021. Planning Committee also observed that in this area, DMIC Corridor is being planned which will have huge economic impact on this area.

Planning Committee noted that planned density levels may be achievable by various measures like increase in FAR, creating conducive climate for industrial/economic activities development and implementation of the DMIC project, and improved connectivity.

After discussions, the Planning Committee agreed that in order to achieve the targeted population and density as per the RP-2021 for Greater Noida, density should be increased by various measures like increase in FAR, creating conducive climate for industrial/ economic activities development and integration of the DMIC proposals.

Issue: Transport

On the issue of BRT, CEO, Greater Noida informed the Planning Committee that a detailed feasibility study for implementation of BRT or similar system is proposed to be carried out separately. He further informed that the BRT or any other successful public transport will be provided based on the feasibility study.

Planning Committee considered and agreed.

#### Issue: EWS/LIG Housing

GNIDA/ Govt. of UP confirmed that a provision of 20-25% of EWS/LIG housing has been made in Modified Master Plan for Greater Noida-2021 and this will be provided while preparing sector layout plans.

Planning Committee considered and agreed.

Issue: Solid Waste Management, Disaster Management & Landuse Plan

The Planning Committee discussed the other issues relating to Solid Waste Management, Disaster Management, Landuse Plan and observed that the observations made by the 59<sup>th</sup> Planning Committee have been incorporated in the Master Plan.

Issues raised by TCPO relating to Water Supply, Power and constitution of Metropolitan Planning Committee for Greater Noida

CEO, Greater Noida informed that the necessary corrections relating to Water Supply and Power have been made in the modified Master Plan submitted to the Board. He further added that since it is an industrial town, Metropolitan Planning Committee is not required to be constituted as per notification of UP Shashan Udhog Anubhag-4 bearing No.6710/77-4-2001-56 bha/99 Lucknow dated 24.12.2001.

After detailed discussions, Planning Committee recommended the Draft Master Plan for Greater Noida-2021 for consideration and approval of the Board with the following conditions: In order to achieve the targeted population and density as per the Regional Plan-2021 for NCR, density levels may be increased by various measures like increase in FAR, creating conducive climate for industrial/ economic activities, integration of the DMIC project and improved connectivity.

Government of U.P./GNIDA may ensure provision of 20-25% of EWS/LIG ii) Housing while preparing of Sector Lay-Out Plans and Development of Greater

Government of U.P./GNIDA may ensure to prepare the Environment Master iii) Plan of Greater Noida which would be integral part of the notified Master Plan.

iv) Green area proposed is 3580 ha. out of total urbanisable area of 22255 ha. which constitutes about 16% of the total area. This area should be preserved /protected and not subject to any land use change at any future date.

Action Plan for implementation and its phasing should be done before V)

notification of the Final Plan by Government of U.P./GNIDA.







We would like to draw your attention to the above letter. The Hon'ble M.P. has requested that Bharatpur should also be made part of the NCR. Bharatpur is an important city of East Rajasthan as well as the head quarter of Bharatpur division. It is well connected with Delhi-Mumbai electric broad gauge railway line and Jaipur-Bandikui-Agra broad gauge railway line. Bharatpur is known as eastern gateway of Rajasthan State and lies between 26° 22' and 27 50' North, and 70° 53' and 76° 17' East enveloping an area of 5066 sq. km. It is surrounded by Gurgaon District of Haryana in the north and the north east, Mathura and Agra districts of U.P. in the east, Dholpur district of Rajasthan in the south east, Karauli in south, Dausa district in the west and Alwar in the North West.

Bharatpur District forms part of the Golden Triangle i.e. Delhi-Agra-Jaipur. Are situated It is 175 kms., from Delhi, the National Capital and 180 kms. from Jaipur the State Capital. Mathura and Agra of Uttar Pradesh at a distance of 35 and 58 kms., respectively. As per Census 2001 the population of Bharatpur was 2,05,235 and is projected to reach 3,70,000 by 2021.

Bharatpur is considered to be one of the important tourist cities in Rajasthan. Bharatpur is bestowed with as Keoladeo National Park (Ghana Bird Sanctuary). Migratory birds fly to Ghana Bird Sanctuary during winters. The migratory Birds accomodate Ducks and Siberian cranes, Indian Cranes, Pelicon, Spoonbill, Flamingos. Shelduck, Pintail, Painted Stork, Goose. The division is famous for its historical towns namely Bharatpur, Deeg, Kumher and Kama.

Attention is drawn to the minutes of 24<sup>th</sup> meeting of NCRPB, New Delhi held on 23.03.1999. Alwar and 7 Tehsils of Bharatpur were included within the expansion of NCR. In this regard a letter no. F.10(136)UDH/3/90 Pt-II dated 14.09.1999 (Appendix - I) of Urban Development Department was written to NCRPB, New Delhi for inclusion of remaining 5 Tehsil of Alwar District namely Bansur, Thanagazi, Rajgarh, Laxmangarh, Kathumar & 7 Tehsil of Bharatpur District namely Kama, Nagar, Deeg, Pahari, Kumher, Nadbai and Bharatpur. In continuation of it in principle approval was accorded in 44<sup>th</sup> meeting of NCRPB, New Delhi. However, while the 5 tehsils of Alwar were included in NCR and notified on September 03, 2004, the 7 tehsils of Bharatpur were not notified. Though, again, in 44<sup>th</sup> meeting in principle approval was accorded for Bharatpur inclusion in to NCR Region further action regarding notification could not be made.

It may be recalled that in the workshop held on 27.12.2011, this issue of inclusion of Bharatpur district in National Capital Region was put forth by the Minister Shri Shanti Kunar Dhariwal, Minister of Urban Development, Housing & Local Self Government, Government of Rajasthan. The undersigned as well emphasised the same during the presentation.

In light of the above the State of Rajasthan once again draws the attention to the need for inclusion of Bharatpur District in the NCR.

Sub: Inclusion of additional areas of Rajasthan in NCR

Madam,

Kindly refer to your letter No. K-14011/28 NCRPB/98-RO (M) dt.13.5.99 regarding the subject mentioned above. There has been a long-standing demand of the state of Rajasthan for inclusion of entire district of Alwar and parts of Bharatpur district in NCR.

In the 24<sup>th</sup> meeting of the NCR Planning Board, the Minister, Urban Development, Govt. of Rajasthan had also requested the Board for inclusion of above mentioned areas in NCR, which was agreed to in principle by the NCR Planning Board.

With the availability of 1991 census data and creation of new tehsils in Bharatpur and Alwar districts, studies were conducted for inclusion of additional areas in NCR. The studies were undertaken on the lines of the earlier study done by Town & Country Planning Organisation in 1973 for delineation of NCR using various indices which came under following categories: -

1. Demographic characteristics and economic profile of the region: Population growth rate, migration, density & employment in non-agricultural activities.

Inter action between Delhi and the surrounding area: Milk supply, vegetable & fruits supply, telecommunication linkages & goods and passenger movement by rail and road.

3. Administrative setup, physiography and efficient framework for urbanisation and infrastructure.

In all, ten criterion were considered under the above mentioned three broad categories. With the lapse of more than 2 decades since the original delineation study was done, the situation with respect to demographic characteristics of the region, interaction between Delhi and surrounding area, level of urbanisation and infrastructure facilities have undergone considerable change. The result of these studies showed that besides the remaining 4 (now 5) tehsils of Alwar district viz. Bansur, Thanagazi, Rajgarh, Lachmangarh & Kathumar (newly created due to bifurcation of Lachmangarh tehsil into Lachmangarh and Kathuman) seven tehsils of Bharatpur district viz. Kaman, Pahari, Nagar, Decg, Kumher, Bharatpur & Nadhar satisfy 5 or more of the above-mentioned criterion. Copies of the studies conducted by the NCR Planning & Monitoring Cell of the State in this regard are enclosed herewith.



## A Brief on National Capital Region

Time and again the need was felt to plan Delhi in the regional context under a suitable legislation which would control and regulate development in the region and finally Parliament enacted the National Capital Region Planning Board Act in 1985 with the concurrence of the constituent State "to provide for the constitution of a planning Board for the preparation of a plan for the development of the National Capital Region and for coordinating and monitoring the implementation of such plan and for evolving harmonized policies for the control of land uses and development of infrastructure in the National Capital Region so as to avoid any haphazard development of that Region and for matters connected therewith or incidental thereto"


#### 1. CONSTITUENT AREAS OF NCR:

 $\cap$ 

The Constituent Areas of the National Capital Region are as under:

- a) National Capital Territory of Delhi (1,483 sq kms.) This accounts for 4.41% of the total area of NCR.
- b) Haryana Sub-region comprising of Faridabad, Gurgaon, Rohtak, Sonepat, Rewari, Jhajjar, Mewat and Panipat districts. This accounts for 30.33% (13,413 sq kms) of the area of the State and 39.95% of the area of NCR.
- c) Rajasthan Sub-region comprises of Alwar Dsitrict. The area is 2.29% (7,829 sq kms) of the total area of the State and 23.32% of the area of NCR.
- d) Uttar Pradesh Sub-region comprising of five districts namely, Meerut, Ghaziabad, Gautam Buddha Nagar, Bulandshar and Baghpat. This accounts for 4.50% (10,853 sq. kms) of the area of the State and 32.32% of the area of NCR.

Thus, the total area of the NCR is 33,758 sq kms as indicated in the Map 1: National Capital Region: Constituent Area.




Map 1: National Capital Region: Constituent Area

#### 2. TRANSPORT NETWORK:

The transport system of NCR as of today consists of well-knit road network and redial rail corridors catering to inter-city and intra-city commuters and long-distance traffic. The freight traffic is also substantial in the region and this is mostly carried by road. Delhi acts as collection and distribution centre for the northern region.

The Regional Plan-2001 for NCR notified in January 1989 formulated a set of policies for the control of land use and development of infrastructure in the region. The Functional Plan Transport prepared and approved by the NCR Planning Board in 1995 envisaged an organized transport network to improve accessibility and the movement of good and passengers within the The Functional region. Plan Transport suggested construction of road



and rail linkages along the high-density routes, in and around the Capital and also in the National Capital Region.

#### 3. RAJASTHAN SUB-REGION:

The Rajasthan Sub-region for the Regional Plan-2021 constitutes Alwar district and includes all the 12 tehsils namely Behror, Mandawar, Kotkasim, Tijara, Kishangarh Bas, Ramgarh, Alwar, Bansur, Thanagazi, Rajgarh, Lachmangarh and Kathumar.

#### 4. INCLUSION OF ADDITIONAL AREAS IN THE NCR:

In the 24th meeting of National Capital Region Flanning Board which had considered the review report of Regional Plan-2001, approved in principle to include additional areas in the NCR subject to considering its implications. In pursuance of this decision, the participating State Govts. have submitted proposals for inclusion of additional areas to the tune of 38,401 Sq. kms., thus, more than doubling its present area. The Sub-region wise details of proposed additional areas are as under:-

(i) Haryana Sub-region:

The whole of the districts of Mahendragarh, Bhiwani and Karnal, Safidon & Jind tehsils of Jind district and Hansi & Naruaund tehsils of Hissar district covering an area of 12,312 Sq. km. approx.

(ii) Rajasthan Sub-region:

The whole of the districts of Bharatpur and Dholpur, Kotputli & Sahapura tehsils of Jaipur district and the remaining five tehsils of Bansur, Thanagazi, Rajgarh, Lachmangarh and Kathumar of Alwar district covering an area of 15,007 Sq. Km. approx.

(iii) Uttar Pradesh Sub-region:

The whole of the districts of Muzaffarnagar, Mathura and Aligarh covering an area of 11,082 Sq. Km. approx.

The additional areas as delineated by the States and approved by the statutory Planning Committee will be placed before the Board in its next meeting for final approval and notification. However these additional areas were excluded in final notification.

## 5. JUSTIFICATION FOR INCLUSION OF BHARATPUR DISTRICT IN NATIONAL CAPITAL REGION:

Although matter of inclusion of additional area in NCR was taken up in the 24th meeting of National Capital Region Planning Board. However these additional areas were excluded in final notification. However Bharatpur district with an area of 5066 sq.km. is all justified for inclusion in the National Capital Region on following grounds:

#### i. CONTIGUITY:

Bharatpur district with on area of 5066 sq.km. is in contiguity with Alwar district and Haryana Sub Region of NCR, which already forms part of National Capital Region, as shown in Map 6.

# ii. FOR ACHIEVING A BALANCED AND HARMONIOUS DEVELOPMENT OF NCR:

Bharatpur being in contiguity with Alwar district forms physically and economically integral part of National Capital Region. District is well connected with Delhi and other cities and towns of National Capital Region. Thus for achieving a balanced and harmonious development of NCR, Bharatpur district should be considered as on integral part for inclusion of National Capital Region.

## iii. FOR ACHIEVING AIMS AND OBJECTIVES OF REGIONAL PLAN 2021:

Bharatpur District has got strong development potentiality to act catalyst for relieving the NCT Delhi from additional pressures, arresting addition new pressures on the capital and promoting development of settlement in NCR to enable then to play their assigned role.

iv. FOR DISPERSAL TO ECONOMIC ACTIVITIES AND ABSORBING FUTURE IN MIGRANTS TO DELHI:

Economy of district is well developed with a great potentiality to take off, will attract new economic activities leading to dispersal of economic activities from NCR-Delhi and absorbing future in-migrants to Delhi.

- v. DEVELOPMENT POTENTIALITY OF BHARATPUR DISTRICT:
  Development potentiality of Bharapur district is sustained because of availability of requisite men and material, infrastructure, contiguity and proximity to NCT Delhi, physically and economically forming on integral part of NCR etc.
- vi. PART OF PROPOSED BHARATPUR-KOTA DEVELOPMENT CORRIDOR:



### Bharatpur District: An Overview (For Inclusion In National Capital Region)

#### 1. PHYSICAL SETTING:

It is an important district in newly created Bharatpur Division, situated in the eastern part of Rajasthan State. Hence it is called eastern gate way of Rajasthan State and lies between 26°22' and 27°50' North Latitude and 70°53' and 76°17' East longitude with an area of 5066 sq. km. Bharatpur District is surrounded by Gurgaon District of Haryana in north and north east, Mathura and Agra districts of U.P. in east, Dholpur district of Rajasthan in south east, Karauli in south, Dausa district in west and Alwar in north west, as indicated in Map: Bharatpur District.



#### 2. RIVER SYSTEM AND WATER RESOURCES:

There is no perennial river in the district. Banganga, Ghambhir and Rooparel are only the main seasonal rivers which flow through the district. Several rain fed nalas and tributaries have been impounded to hold water for drinking and irrigation purposes.

#### 3. ADMINISTRATIVE SET UP:

Bharatpur city is headquarters of newly created Bharatpur Division and Deputy Inspector General of police Department. Bharatpur District Comprises of 3 Sub Divisional headquarters which further sub divided in 10 tehsils as follows, as indicated in Map 5:, Bharatpur District.

(a) Bharatpur

Bharapur, Nadbai, Kumher

(b) Bayana

Bayana, Roopwas, Weir

(c) Deeg

Deeg, Kaman, Phari, Nagar

#### 4. MORPHOLOGY AND CLIMATE:

Morphologically Bharatpur district is by and large characterized by a large tracts of plains with a few scattered hillocks in Bayana and Roopwas tehsils. Land of Bharatpur district is characterized

by plain fertile agricultural land.

District has a dry climate with a hot summer (March to June) when the diurnal temperature varies from 28° to 46° or even more, a cold winter and a short mansoon season. The cold season starts by about the middle of November and continues upto the beginning of March. The hot season follows thereafter and extends up to the end of June. The South - West mansoon season from July to mid September records 90% of the average annual rainfall of 67 cm when relative homidity is more than 70%. The period from mid September to mid November may be termed the post mansoon season.

#### 5. DEMOGRAPHY:

Population of Bharatpur district has increased from 10,30,555 in 1971 to 21,01,142 in 2001 as shown in Table No.1

Amogst tehsils 3,72,876 persons inhabited in Bharatpur tehsil in 2001 followed by 2,37,261 persons in Weir tehsil and 2,25,348 persons in Bayana tehsil. Population density of district was 414 persons per Sq. Km. and sex ratio worked out 857 females per 1000 males. Average literacy rate worked out 63.06%, while it was 80.5% for males and 43.6% for females. There are 1578 revenue villages and 9 towns in the district. 81.53% population (16,92,182 persons) lived in rural areas while remaining 19.47% (4,08,960 persons) lived in urban areas. Bharatpur being class I city is the biggest urban Centre of district.

#### 6. ECONOMIC PROFILE

The participation rate was 27.28% in 2001 and marginal workers were 13.35%. Participation was higher amongst females (68.26%) than males (57.10%). Study indicates a gradual shift in occupational structure from primary activities to secondary and tertiary sector activities.

District is characterized by fairly well developed rural economy besides being heavily based on agriculture and other primary activities such as brick kilns, dairy etc. Net sown area is 78% (3, 96,018 hectares) of total geographical area of district, while double cropped area is 41% (2, 07,060 hectares) of total geographical area. Bharatpur district is famous for the production of

rape-seed and honey. Red sand stone is in great demand from various corners.

However significant development in industrial and commercial sectors has also taken place on account of availability of infrastructure facilities such as water, electricity, transport communication, technical education etc. in the district. Bharatpur being major industrial centre and Deeg, Bayana, Kaman, Nadbai etc. agro based industrial centers have been playing an important role in overall district economy. RICCO is developing 6 industrial areas for industrial development in the district. Industrial area being developed in Juhara village in Kaman tehsil has a great potential on account proximity to Delhi.

Trade and commerce forms another important component of the economic base of the district. Commercial activities are fairly developed in Alwar, Deeg, Nadbai & Bayana. There are several wholesale mandies in the district dealing in commodities like foodgrain, rapeseed, vegetable oil, etc. Weaving Sculpture, leather, products, agricultural food and potteries are some of the

prominent informal sector activities.

The employment in Government and semi Government services is mainly centralized at district headquarter Bharatpur and Sub-divisional headquarters Deeg, Bayana, besides Nadbai being railway station.

7. TRANSPORT NETWORK

Bharatpur district is well connected with cities and towns of nearby States and State of Rajasthan by both rail and road network. Existing transport network in the district converges towards Bharatpur city, being Divisional cum District headquarters.

- (a) Road Network: National Highway No.11 State Highway No. 14 Bharatpur-Alwar and SH No. 24 Hindon-Mathura through district. Besides, all tehsil headquarter are internally well connected by Major District Roads (MDR) which are further connected by ODR and village roads with rural settlements of their hinterlands.
- (b) Rail Network: The district is well served by Delhi-Bombay and Agra-Jaipur broad-gauge railway lines. Delhi-Bombay section is electrified while Agra-Jaipur is running on diesal traction system and catering inter-city mail/express trains, ordinary passenger and freight trains 8. POWER

The power supply system of Rajasthan forms part of the Northern Grid which is overseen by the Northern Regional Electricity Board (NREB). It gets power through various Central and State generating stations and, in turn, supplies power to the constituent States. Although the overall control and monitoring of the Northern Regional Grid operation is by the NREB, the basic management and control of the power supply system in the State is by the State Government through the Jaipur Electricity Distribution Corporation (JEDC) in case of Bharatpur district. While (JEDC) is responsible for developing the Distribution system. The Power Grid

Corporation of India Ltd. (PGCIL) is responsible for developing the central sector transmission system, including setting up of the National Power Grid.

- (a) Rural Electrification: The number of village electrified in the district varies. 85% of villages in district have been electrified. The actual number of village electrified as on 2009 are 1336 out of 1578.
- (b) Power Consumption Pattern: The major consumers of power are agricultural (35%), industrial (20%) and domestic (27%), Power consumption varies for different consumer categories. Details of consumption pattern in 2009-10 are as follow:

#### 9. WATER SUPPLY:

For the improvement of quality of life of rural people, large amount of funds are provided through the Rajiv Gandhi Drinking Water Mission in the Central sector to supplement State efforts through Mininum Needs Programmes. Govt. has taken concrete action to supply safe drinking water to 1366 out of 1578 revenue villages by 2009. Government also plans to cover al the habitations affected with problems like saline, brackishness, fluorosis etc. under this programme.

- (a) Urban:- In the district Public Health Engineering Department, is mainly responsible for water supply. Main sources of drinking water are deep tubewells and dams. In Bharatpur city, water supply is @ 78 lpcd thus totalling 42 lakhs gallons per day.
- (b) Rural:- Public Health Engineering Department of the State is responsible for operation and maintenance of drinking water supply in rural areas. Main sources of water supply in rural areas are tubewells and hand pumps.

#### 10. TOURIST FACILITIES

Being located on "Golden Triangle" formed by Delhi-Agra-Jaipur on National Highway No. 11, Bharatpur district has been bestowed with many tourist sites which attracted a large number of tourists round the year. Keoladeo National Park (Ghana Bird Senctuary) Ganga Mandir, Laxman Mandir, Kishori Mahal, Jama Masjid, Lohagarh Fort, Museum etc. are in Bharatpur city.

Keoladeo National Park has been declared "World Heritage" by UNESCO. With the advance of winter, migratory birds fly to drop in Ghana Bird Sanctuary. The important amongst the

migratory birds are variety of Ducks and Siberian cranes, Indian cranes, Pelicon, Spoonbill, Flamingos, Shelduck, Pintail, Painted Stork, Goose etc. One has the unique advantage of seeing the land animals like Sambhar, spotted, deer chinkara and even the panther in the adjoining forest. For lodging and boarding of tourists, forest lodge has been established by Indian Tourism Development Corporation. Saras Tourist Bungalow is run by Rajasthan Tourism Development Corporation.

Lohagarh Fort with high walls and surrounded by a moat, which is about 200ft. wide attracts a

large number of tourists.

Palaces and colourful fountains of Deeg, are word fame for their own charm.

Kaman has also got many religious places forming the part of Braj Mandal of 84 Kos and palaces of tourist attraction.

Bandhbarentha is another picnic spot at the distance of 60K.m. from Bharatpur.

2. It is true that Bhiwani and Narnaul Towns located in Bhiwani and Mohindergarh districts respectively, are adjacent to the NCR Boundary. Being unaware of the process of inviting suggestions earlier in 2010, we could not make suggestions at that time and thus missed the opportunity of having the two towns, namely, Bhiwani and Narnaul included in the Counter Magnet Areas. However, considering the fact that these two towns fall in the backward area due to desert conditions. I would urge NCRPB to send a team to Bhiwani and Narnaul to have a fresh assessment on the subject.

3. I would, therefore, request once again to consider inclusion of these two towns as Counter Magnet Areas. In case, it is not possible at this stage, these two towns of Bhiwani and Narnaul may be included in the NCR, which will equally more appropriate. This will certainly improve the basic amenities and infrastructure in these towns, thereby restricting exodus of people to Delhi.

The approved draft was published for objections/suggestions for 30 days vide notification number JDA/STP(MP) 2009 -10 /D-312 on 6.11.09 which was extended time to time in all giving 22 months for consultations:

# **Objectives**

- Jaipur needs to be prepared and positioned for a mega city generator of economic momentum for global exchange through quality services and infrastructure.
- Jaipur instead of remaining, just a State hub of economic activities, should become a national hub of economic activities, to enable it to play its due role as a national city and help the State of Rajasthan to position it as globally competitive State.
- Jaipur in the process should be able to siphon off some of the economic activities from global city net work.
- It is not just preparation of Master Development Plan, but to develop a global brand value for Jaipur through an implementable plan with a long-term perspective, phased development and coordination of dedicated budgets.
- Jaipur should take advantage of its architectural and cultural heritage to place it on global map as a world class tourism destination.

In all 1036 objection / suggestions were considered which were received till 30.08.2011.

The U-3 area is divided in to Low intensity Zone and High Intensity Zone i.e.; the U3 area overlapping with G2 shall be considered as Low intensity Zone while the rest of the U3 area shall fall under High intensity Zone. The projected U3 area 2025 under HIZ is 96 sq km. and under LIZ is 39 sq km.

In the U3 LIZ area, Low impact development (LID) techniques shall be used for land development by Conservation of drainage, trees & vegetation. Development impacts in this area to be minimized by low intensity development.

The growth foci, focal villages and service villages falling in rural area are provided with 500 mt radius from the existing village abadi to accommodate growing needs of the settlement. The use is designated as mixed use.

The Master Development Plan 2025 for Jaipur City, Master Plan for 11 Satellite towns and 4 Growth Centers have been prepared which attend to the needs of growing population.

In order to give good quality of life in the transportation system the plan give utmost priority to public transport system like Metro, BRTS and Ring road. The Ring road envisaged with a length of 125 Km. around the city of Jaipur and

Jaipur city land uses have been accommodated within the ring road. An efficient road network of 30mtr. and above is envisaged in an envelope of around 2000 Sq.Km. area.

The New Master Plan ventured into providing good quality of life by defining broad land use which would be further carried out by Development Promotion and Control Regulation.

Master Development Plan is prepared on GIS platform which is use friendly and the process of uploading it on internet platform shall usher a new era of transparency and easy access to the general public.

In order to give the green coverage the plan envisages 1 district park, 6 central parks. In addition of the future residential projects having an area of 2 to 10 hectares shall earmark 5% and projects area having 10 hectares and more shall earmark 10% of the total land exclusively for parks and open space. The bigger projects shall be accommodated as far as possible for creation of new central parks and regional parks by way of land pooling.

The Affordable Housing Policy has given its prominence by promoting this activity in all use zone except G-1.

The hierarchical commercial establishment by way of one sub-city centres and a new district centres envisaged in the plan. In addition, commercial areas and mixed land use have been provided.

A notable provision for checking the spread of commercial establishment on major junction of roads having 18 mtr., with rotaries or traffic islands and on either side of ROB's, Fly over's the future permissions will not be accorded on such traffic problem areas.

In residential areas vending zones as per State Government planning policy is encouraged.

# AGENDA ITEM NO.1: CONFIRMATION OF THE MINUTES OF THE 60<sup>TH</sup> MEETING OF THE PLANNING COMMITTEE HELD ON 28:06.2012

Minutes of the 60<sup>th</sup> meeting of the Planning Committee held on 28.06.2012 were circulated vide letter No. K-14011/28/2012-NCRPB dated 03.07.2012. No comments have been received. The minutes were confirmed.

# AGENDA ITEM NO.2: ACTION TAKEN REPORT ON THE DECISIONS OF THE 60<sup>TH</sup> MEETING OF THE PLANNING COMMITTEE HELD ON 28.06.2012

Action Taken Report on the issues/decisions taken in the last meeting were reviewed.

### i) Development of Highway Corridor Zones

It was informed that in the Haryana Sub-Region only one stretch of about 16-17 kms. between Rohtak and Meham on NH-10 has not been notified as controlled area.

- ii) Status of preparation of Sub-Regional Plans
- a) Draft Sub-Regional Plan for U.P. Sub-region-2021 was discussed at Agenda item No.4.
- b) Haryana Sub-region

Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana informed that the Draft Sub-Regional Plan-2021 for Haryana Sub-Region is under finalization and will be submitted to the NCRPB by the end of June, 2013.

## c) Rajasthan Sub-region

Additional Chief Secretary, Local Self Government, Department of Urban Development & Housing, Govt. of Rajasthan informed that the Draft Sub-Regional Plan-2021 for Rajasthan Sub-Region will be submitted by the end of July, 2013.

# d) Delhi Sub-region

Special Secretary, GNCT-Delhi informed that the preparation of Sub-Regional Plan for Delhi Sub-Region is in the process.

# iii) Consideration of Draft Master Plan for Greater Noida-2021

Planning Committee reviewed the approval of Greater Noida Master Plan. It was observed that the conditions for provisions for 20-25% of EWS/LIG housing and Environment Master Plan were not incorporated in the Master Plan. Planning Committee decided that both the provisions to be incorporated in the Master Plan of Greater Noida-2021.

# iv) Review of Co-opted Members to the Planning Committee.

The Planning Committee noted.

# AGENDA ITEM NO.3: CONSIDERATION OF DRAFT REVISED REGIONAL PLAN 2021 FOR NCR

Chairperson informed that the draft Revised Regional Plan-2021 for NCR was circulated to all the members of the Planning Committee members were requested to give their suggestions. Then Chapter-wise discussions were taken up:

#### Chapter-1: Introduction

No change suggested by the Planning Committee.

#### Chapter-2: The Region

The Planning Committee noted that the area of the CNCR has been corrected as provided by the State Govts. from 33,578 sq.km. to 34,144 sq.km. due to reorganization of Panipat district and confirmation of the area of Alwar district.

#### Chapter-3: Aims, Objectives and Policy Zones

- i) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana stated that since there is no specific reason for reorganization of CNCR, the CNCR as defined in the RP-2021 may be retained.
- ii) Commissioner, NCR Cell, Govt. of UP stated that increasing the CNCR boundary without economic incentives, would not amount to any value addition.

After detailed discussions, Planning Committee decided that the existing CNCR will be retained with the current Development/Controlled/Regulated Areas. Accordingly, the para 3.2.2 of the draft Revised Regional Plan-2021 for NCR should be modified.

#### Chapter-4: Demographic Profile and Settlement Pattern

- i) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana stated that population of 7.64 lakhs for 2021 AD has been proposed in the notified Master Plan of Rohtak and suggested that the Table 4.14 (Projected Population for NCR-2021) may accordingly be modified. He suggested that the area figures given for the Districts of Haryana may also be corrected as per the Statistical Abstract-2011-12. He further added that population of Rewarl for 2011 also needs to be corrected to 1.43 lakhs.
- ii) Additional Chief Secretary, Local Self Government, Department of Urban Development & Housing, Govt. of Rajasthan stated that in Table 4.9 (Proposed Regional Centres-2021) the population for Alwar has been proposed as 4.5 lakhs by 2021 and should be corrected as 5.35 lakhs. Similarly, proposed population for Greater Bhiwadi and SNB Complex should be corrected to 8.09 lakhs and 5.35 lakhs respectively by 2021 in the Revised Regional Plan-2021.
- iii) Commissioner, NCR Cell, Govt. of UP pointed out that UP Sub-regional Plan-2021 has proposed Yamuna Expressway Industrial Development Authority (YEIDA) as a Metro Centre and suggested that in Table 4.18 (Proposed Metro Centres 2021). It was decided that the following note may added below the Table 4.18.

"UP SRP-2021 has proposed a new township YEIDA under the provision of para 4.3.5 (1) of the RP-2021 as a green field township".

v) Chief Town Planner, NCR, Rajasthan stated that in para 4.3.4 (ii) "four or five new Metro Centres / Regional Centres and other new townships can be developed" has been mentioned and suggested that the number of new township should not be limited to four or five, hence, this may be deleted. He further suggested that in addition to Metro Centres /Regional Centres, Investment Region may also be added.

After detailed discussions, it was decided that the above modifications will be carried out in this Chapter.

#### Chapter-5: Economic Scenario

No change suggested by the Planning Committee.

#### Chapter-6: Transport

i) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana observed the following:

All the above suggestions would be incorporated except extension of Metro to Kundli because EGOM directed DMRC to conduct a survey for taking a spur from Rithala-Bawana line to Narela in Delhi and onwards to Kundli in Haryana.

ii) Additional Chief Secretary, LSG, UD&H, Govt. of Rajasthan stated that Green Field Airport is under consideration at Kotkasim whereas in revised Regional Plan 2021 it has been mentioned as Alwar town and suggested that the location of smaller airport should not be site specific and it should be district. He further suggested that the alignment of new link road between Neemrana-Bhiwadi may be added.

After detailed discussions, it was decided that the above may be incorporated in para 6.8.4 and Neemrana-Bhiwadi link road may also be incorporated.

Chapter-14: Environment

i) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana stated that land suitability analysis can be carried out in the case of new towns. He suggested that para 14.6.5 (iii) may be modified. Additional Chief Secretary, LSG&UD&H, Govt. of Rajasthan also expressed the same view.

After detailed discussions, the Planning Committee decided that the para 14.6.5 (iii) may be modified as follows:

"Master/Development plans for the new towns in the region should incorporate land suitability analysis for land use allocations, which would identify areas intrinsically suitable for urban activities, agriculture, forestry, industry and recreational uses".

ii) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana stated that in para 14.6.5 (vi) (b) "in the district of Gurgaon up to the date of this notification" may be deleted as the Act is applicable for whole of Haryana State. Accordingly, it was decided to correct para 14.6.5 (vi) (b) as follows:

"All areas covered by the notification issued under Section 4 and 5 of the Punjab Land Preservation Act, 1900, as applicable to the State of Haryana"

The Planning Committee agreed.

No change suggested by the Planning Committee.

No change suggested by the Planning Committee.

# Chapter-17: Regional Landuse

i) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana informed that the provision relating to RIS/SSI units need modification, as per potentiality of the area/Development Plan. Same may not be allowed in hyper/high potential zones/towns. After detailed discussions, it was decided that the following note will be added below para 17.5.1 (b) at 4 (ii):

"Note: State Governments may further restrict setting up of industries as per Master/Development Plans provisions".

ii) The matter of city level density norms were discussed. Members from the participating States observed that there is no provision for special purpose towns like industrial, knowledge city, sports city, etc. and suggested that the city level density norms could be reduced by 10% for

such towns. After detailed discussions, it was decided that the following note will be added below Table 17.9 in para 17.4.1 (a):

"Note: The density could be further reduced by 10% for special purpose township such as industrial town, knowledge city, sports city, etc."

- iii) With regard to Natural Conservation Zone at para 17.4.3 (v), after detailed discussions the para has been modified as under:
  - (v) Detailed Conservation Plans be prepared for the areas shown as Natural Area Conservation Zone in the Land Use Plan 2021 by the concerned State Governments/Agencies along with guidelines for development activities in conformity with environmental laws.
- iv) Additional Chief Secretary, LSG, UD & H, Govt. of Rajasthan suggested that the recreational/tourist facilities should be a permissible activity in the "Agriculture (Rural) Zone within Controlled/ Development/Regulated Areas". Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana suggested that in the Natural Conservation Zone [Para 17.5.3 (iv)], relating to Regional/Recreational activities, restriction constructions of 0.5% may be deleted.

After detailed discussions, it was decided that a provision for "recreational and tourist facilities" may be added as Sl. No. 23 in para 17.5.1 (b) and the provision in Para 17.5.3 (iv) may be modified as "regional recreational activities after obtaining environmental clearance from the Competent Authority".

v) It was pointed out that the draft revised Proposed Landuse Map-2021 should be prepared and added in the Plan document. Chief Regional Planner, NCRPB mentioned that the proposed Landuse Map is being prepared by NRSC. After detailed discussions, it was decided that since the Proposed Landuse Map as contained in the Regional Plan-2021 prepared for the perspective year 2021, the 'urbanizable area' for the Metro Centre and Regional Centre shown on the proposed Land Use Map-2021 will remain the same with minor modification, if required and new proposals such as Transport, Highway Corridor Zones, Natural Conservations Zone, etc., may be added.

After detailed deliberations, Planning Committee recommended the draft Revised Regional Plan-2021 for placing the same after incorporating the suggestions before the Board for approval for inviting objections / suggestions from the public under Section 12 (1) of NCRPB Act, 1985.

# AGENDA ITEM NO.4: CONSIDERATION OF SUB-REGIONAL PLAN FOR UP SUB-REGION 2021

- i) Commissioner, NCR Cell, Govt. of UP presented the Draft Sub-Regional Plan for UP Sub-Region-2021 in the meeting. She mentioned that most of the suggestions/observations of the NCRPB have been incorporated in the Draft Sub-Regional Plan. While presenting the Plan she mentioned that a new green field township of Yamuna Expressway Industrial Development Authority (YEIDA) with a population of 20 lakhs over an area of 20,000 ha. by 2021 has been proposed in the Draft Sub-Regional Plan.
- ii) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana mentioned that development of YEIDA for a population of 20 lakhs by 2021 would be difficult to attain. Commissioner, NCR Cell, U.P. reiterated that the YEIDA was earlier planned for much higher population which has been reduced and the 'urbanisable area' has also been reduced to the minimum restricting to that area where already infrastructure development

activities have started. Area of YEIDA has 5 lakhs rural population which likely to reach about 8 lakhs by 2021. She further mentioned that Govt. of UP has already approved this new township.

- iii) It was pointed out that the YEIDA is located outside the CNCR and falls in "Rest of the NCR" Policy zone. For this zone, Regional Plan-2021 envisaged accelerated development and substantial upgradation of infrastructure in order to induce the growth which will make them attractive for locating economic and allied activities and private sectors.
- iv) The Planning Committee observed that the following observations of the NCRPB on the comments of Govt. of UP vide letter dated 22.05.2013 have not been corrected/incorporated in the draft Sub-Regional Plan for UP Sub-Region-2021:
  - a. In case of Bulandshar-Khurja complex, population of this complex is 3.78 lakhs as per Census 2011. Whereas Sub-regional Plan mentioned 3.33 lakhs (Table 3-34). This should be corrected.
  - b. No provision has been given for Post-Disaster Management Plan. Provision for Post-Disaster Management Plan be added.
  - c. No comprehensive study on the Implementation Strategies, Management Structure & Resource Mobilization was carried out by NCRPB. Accordingly, the statement mentioned in Page-368 to be amended.

After detailed deliberations by the members of the Planning Committee, draft Sub-Regional Plan for UP Sub-Region-2021 was recommended with the following conditions:

- 1. Existing Landuse analysis and the existing Landuse Map-2012 prepared by NRSC, Department of Space, Govt. of India will be incorporated in the Sub-Regional Plan.
- 2. Zoning Regulations of Draft Sub-Regional Plan for UP Sub-Region-2021 will be in conformity with Regional Plan-2021.
- 3. Urbanisable area of Master Plan of Metro and Regional Centres in the UP Sub-Region will be as per the approved Master Plans- 2021.
- 4. Observations/suggestions of NCRPB which have not been incorporated in the Sub-Regional Plan mentioned in para (iv) above be incorporated.

The Draft Sub-Regional Plan for UP Sub-Region-2021 along with the recommendations with conditions of the Planning Committee will be placed before the Board for consideration and approval.

# AGENDA ITEM NO.5: CONSIDERATION OF PROPOSAL OF INCLUSION OF ADDITIONAL AREA IN NCR AND IDENTIFICATION OF JAIPUR AS COUNTER MAGNET AREA.

## 5.1 Proposal of inclusion of Additional Area in NCR

- i) Chairperson stated that Board has received proposals from Govt. of Rajasthan and Govt. of Haryana for inclusion of Bharatpur district of Rajasthan and Mahendragarh and Bhiwani districts of Haryana respectively. She stated that Govt. of UP has requested to include Mathura district in NCR and if Mathura district is included, for maintaining the contiguity two districts namely Aligarh and Mahamaya Nagar need to be included in NCR. Govt. of U.P. has requested that this may be examined by the Study Group constituted for review and revision Regional Plan-2021.
- ii) A presentation was made on the proposals and the recommendations of the Study Group-I: NCR Policy Zone, Demographic Profile, Settlement Pattern, Regional Landuse and Rural Development and the Steering Committee constituted for review and revision of the Regional Plan before the Planning Committee. The Planning Committee observed that inclusion

- of Bharatpur, Mahendragarh, Bhiwani and Mathura (including Aligarh and Mahamaya nagar) districts would result in increase the area of NCR by 61% (from 34,144 sq.km. to 55,068 sq.km.).
- iii) Additional Chief Secretary, LSG, UD&H, Govt. of Rajasthan stated that Bharatpur is contiguous to existing NCR boundary (Alwar district) and is well connected with road and rail and also part of Golden triangle Delhi-Agra- Jaipur. It was stated that there is no vibrant economic and urban development in the south-east direction of NCR to create balanced development. Bharatpur district can fill this gap which can offer economic and infrastructure viability for this part of the region with Bharatpur city being focus. Therefore, he reiterated the request of the State Govt. that Bharatpur district may be included in the NCR.
- iv) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana stated that both the districts of Mahendragarh and Bhiwani in Haryana are contiguous to existing NCR area of Haryana Sub-region and are well connected with the capital city of Delhi by road and rail. He further mentioned that Govt. of Haryana had recommended the proposal for inclusion of these districts in NCR.
- v) Planning Committee noted the recommendations of the Study Group-I and suggestions of Steering Committee. In the case of inclusion of Mathura, Aligarh and Mahamaya Nagar districts, Govt. of U.P. will send a formal proposal to the NCRPB.

The Planning Committee considered the proposals and recommended for inclusion of Bharatpur, Bhiwani and Mahendragarh districts in NCR for the following reasons:

- i. Contiguous to existing NCR area.
- ii. Equi-distant from Delhi.
- iii. Good connectivity with Delhi by rail and road.
- iv. Would help in dispersal of economic activities.

The recommendations of the Planning Committee will be placed before the Board for consideration and approval.

# 5.2 Proposal for identification of Jaipur as a Counter Magnet Area

- i) Additional Chief Secretary, LSG, UD&H, Govt. of Rajasthan stated that Jaipur is a Metropolitan city with a population of 36.47 lakhs as per 2011 Census and the capital of the Rajasthan State located at a distance of 250 km. from Delhi. It is a historical city and a very important tourist place and has potential for development as a Counter Magnet to Delhi.
- ii) Financial Commissioner & Principal Secretary, Town & Country Planning Department, Govt. of Haryana has suggested that selection of Jaipur as a Counter Magnet need not wait for the migration data of Census 2011 as suggested by the Study Group and the Steering Committee.

Planning Committee considered the proposal and recommended that Jaipur may be identified as Counter Magnet Area. The proposal for identification of Jaipur as Counter Magnet along with the recommendations of the Planning Committee will be placed before the Board for consideration and approval.

The meeting ended with a vote of thanks to the Chair.


