1. List of participants is at *Annexure-I*. Discussions were held as follows:

AGENDA ITEM: Status of Implementation of Combined Reciprocal Common Transport Agreement (CRCTA).

- 1. The committee was apprised that NCR States had hereafter finalized and agreed on the Combined Agreement called the 'Combined Reciprocal Common Transport Agreement (Stage and Contract Carriage)' amongst the Government of Haryana, NCT-Delhi, Rajasthan and Uttar Pradesh on 31-08-2021 and status shared in the 40th Board Meeting of the Board held on 31.08.2021. The NCR participating States are now in process of taking necessary action regarding publication u/s (5) of the Motor Vehicle Act 1988 within their States before Gazette Notification of the agreement.
- 2. CoTS in its meeting held on 16.09.2021 unanimously decided that "the validity of the Order issued on 09.07.21 is till three months beyond 09.07.21 for Contract Carriage and 18.07.2021 for Stage Carriage, its further extension if required will be decided based on progress achieved by States on the signed CRCTA, in the next CoTS meeting scheduled for 08.10.2021".
- 3. Chairperson appreciated Rajasthan for early action on publication of signed CRCTA and requested Haryana, Uttar Pradesh and NCT of Delhi to share current status on progress achieved by States on signed CRCTA.

 Shri R.C.Yadav, Rajasthan informed that Rajasthan has published the CRCTA u/s 88(5) of CMV Act,1988 on 23.09.2021. On query of Chairperson, Shri Yadav mentioned that Rajasthan has published in English only. If required, Hindi version also may be published.

Rajasthan has published in English only. If required, Hindi version also may be published. Chairperson suggested that Rajasthan may also check the conformity as per applicable laws. Shri Sehrawat, Addl. Transport Commissioner, Haryana suggested that to make uniformity of CRCTA, NCRPB may share Hindi version. Chairperson directed concerned officers for arranging Hindi version to NCR participating States for uniformity and finalized it

5. Shri K K Dhaiya, Special Transport Commissioner, Transport Department, Delhi informed

that English version has been approved by Law Department, Delhi and final copy has

already been sent to Minister of Transport. After this, it will be submitted to LG, Delhi for

approval and it may be published before end of next week i.e. 14th October, 2021.

Meanwhile, Hindi version is also under preparation.

6. Shri Rajiv Kumar Shrivastava, Deputy Transport Commissioner, Meerut mentioned that

matter has been approved and submitted to Vidhai & Law Department, Govt. of Uttar

Pradesh before publication under provision of the Motor Vehicle Act 1988. Chairperson

requested to expedite and complete by 13th October, 2021.

With regard to the extension, after deliberation, it was decided that the terms and conditions

of both the existing Reciprocal Common Transport Agreements shall be abided and status

quo be maintained by NCR participating States up to 06.12.2021 for Contract Carriage and

Stage Carriage or till further orders, whichever is earlier.
