Agenda Item No. 3.1: Phase-II - Development of Integrated Aviation Hub, Hisar

Introduction

The Government of Haryana has envisaged development of an international airport at Hisar. Hisar district, located in the western Haryana, is one of the nine designated counter magnet area to National Capital Region (NCR) as per the NCR Planning Board. Development of the airport is expected to connect cities or towns such as Hisar, Bhiwani, Jind, Sirsa, Charkhi Dadri etc. to the national as well as global aviation network. This is also likely to boost industrialization, multi-modal-connectivity, and real estate development in the region as it would integrate various facilities in the hinterland to the national as well as global value chains. The proposed airport may also help in decongestion of IGI Airport in Delhi, which is soon expected to reach its capacity.

Hisar airport located in NCR's counter magnet region has potential to cater to the demand of the districts surrounding Hisar district as well as other regions of the Punjab, Haryana, Rajasthan and Delhi-NCR. Airport is also expected to decongest IGI airport.

The Government of Haryana has a 3-phase plan for the development of Hisar airport. In Phase 1, the airport is to be developed to cater to the UDAN domestic routes under the RCS scheme (Delhi-Hisar and Hisar-Chandigarh routes are scheduled to be catered by a 19-seater aircraft by Pinnacle airlines in the coming months (based on the routes awarded by AAI/ MOCA under UDAN 2). In Phase-II, the airport is envisaged to have small scale MRO, fixed base operation, and Defense manufacturing and Defense MRO. In the final Phase 3, the airport is expected to be upgraded to an international airport with development of an integrated aviation hub including aerospace manufacturing, aviation training center, aviation University.

Description of the project site

The area of land earmarked for the proposed Integrated aviation hub has been culled from parcels of government land contained within the administrative village of Bir, district Hisar. The proposed layout is adjacent to the existing airport at Hisar and along the NH 10 or Hisar-Delhi Bypass Road. The proposed aviation hub site is located amidst the Chandigarh-Sirsa by-pass on the Northern boundary, and the Hisar-Delhi bypass on the southern boundary, Hisar-Sirsa bypass along the western boundary, and a patch of forestland on the eastern side. The previously National Highway through Barwala, also called the Barwala road, cuts across the proposed site and will be closed consequent to preparing the site for development and is currently designated as an ODR- Ordinary District Road instead of a National Highway.



Potential of Passenger Traffic

In the radial zone of around 400km of Hisar airport, four major airports are located- IGI Airport, Jaipur Airport, Chandigarh Airport and Amritsar Airport. It is expected that traffic from these airports will shift to Hisar airport, with majority of the shift getting realized from IGI airport due to high traffic at IGI airport compared to another airport.

Potential of Cargo Traffic

In the last five years, cargo traffic at IGI airport has increased at a CAGR of 11%. Total cargo traffic handled at IGI airport in 2018-19 was 1043 thousand MT.

Export cargo accounts for nearly 35% of the international cargo at IGI airport. Electronics is one of the key commodities being exported from IGI airport followed by machinery parts, perishable etc. 65% of cargo movement is imports with electrical and machinery are the major import commodities handled at the airport.

Around 75% of the cargo movement at IGI is from NCR Delhi. Commodities such as perishables, pharmaceuticals, electronics, machine parts, auto component (which typically constitute air cargo) from Hisar hinterland account for about 1-2% of the total international cargo at the IGI airport. Among domestic cargo, courier is the major commodity, demand of which is expected to be governed by the demography and urbanization of the region.

Multi-variable linear and logarithmic regression models are used to estimate the overall cargo demand in the hinterland. Out of the total demand, realizable demand at Hisar airport is estimated based on multiple factors: a) investment planned in the hinterland, particularly in industries that rely on air transport (like electronics, pharmaceutical etc.); b) distance between the airport and the cargo generating centers; c) air connectivity at the airport and d) cargo holding capacity available on particular routes (dependent on air craft movement) e) feasibility of the regular freighter service at the airport. Currently, air bound perishable and livestock cargo is moving from the Hisar airport's hinterland to other airport such as Mumbai and (or) Nashik for further movement to middle east and CIS countries by freighter aircrafts. Therefore, Hisar being proximate to cargo generating centers may cater to freighter aircrafts (Code-C or Code-E) from FY-2024 to Middle East and CIS destinations.

Based on demand and supply side factors, overall cargo demand at the airport is expected to be $\sim\!24.5$ thousand tons in FY 2024, which may reach to $\sim\!70$ thousand MT, $\sim\!111$ thousand MT and $\sim\!258$ thousand MT by FY2035, FY 2040 and FY 2045 respectively.

Proposal for consideration of the Group

The project has been appraised from planning, financial, environmental & social point of view. It is proposed that PSMG-I may take a view on the submitted project proposal received from Civil Aviation Haryana and accord approval for financial assistance to the tune of maximum Rs. 700 Cr. i.e., upto 75% of the project cost of Rs. 946 Cr. (as per details at Appendix-1) by NCRPB on the aforementioned project subject to the fulfilment of the following criteria and providing of the applicable information / document prior to issuance of administrative sanction by the Board:-

 Member Secretary, NCRPB may be authorized to take a decision in case of any issue which may arise in terms of technical feasibility, compliance of Statutory and



- Environment & Social requirements for the aforementioned project viz. Survey Report (Trees) mentioned as *Annexure 6* in the reply dated 24.05.2021.
- ii) Necessary required clearances should be arranged by IA in a timely manner and IA should ensure that the project should be implemented as per the schedule.
- iii) Land required for project implementation should be in the possession and name of the IA.
- iv) Requisite necessary statutory clearances from all Departments which are involved in the project implementation should be taken by the IA in a timely manner so that the project implementation should not face any hurdle during implementation including Approval of the Civil Aviation Department/DGCA of GOI and Notification of Counter Magnet Area.
- v) Requisite Social & Environmental Reports, as applicable.
- vi) Any other compliance as required by NCRPB during the course of the project implementation.
- vii) Requisite administrative & financial approvals for the revised estimates (if any) to be provided by Civil Aviation Haryana.
- viii)Any cost increase over and above the current estimates shall be borne by the agency and all efforts to complete the projects be ensured accordingly.
- ix) Security proposed to be offered (State Guarantee/ Bank Guarantee @ 133.33% of the loan) against the loan drawal from NCRPB. In case of direct loan to State Government, and an undertaking with regard to budget provision for repayment of loan/interest would be required.

Agenda Item No. 4: Proposal of Haryana Government for SDG Economic Recovery Bonds to be raised through eligible Central PSUs

- 1. Finance Department, Govt of Haryana, vide their letter No.3/1/2021-SDG Bonds (2) dated 18.6.2021 has informed that the Haryana Government intends to set up a Haryana SDG Economic Recovery Fund to provide a platform for potential investors to partner with Government in its endeavour of post Covid economic recovery to bridge the SDG financing gap and to give fillip to investment for economic growth.
- 2. The State Government has developed a pipeline of flag ship schemes/projects with a significant investment of approximately Rs.30,000 crores. The key projects in the pipeline include projects that involve upgradation of health and medical education facilities, creation of critical rail and road infrastructure, establishing cold chains and marketing facilities for horticulture produce and water conservation. In order to implement these projects, project specific Special Purpose Vehicles (SPVs) are being established. Haryana State Financial Services Ltd (HSFSLI a State Government undertaking has been tasked to anchor the Haryana SDG Economic Recovery Fund, and raise funds from the market for this purpose.
- 3. It has been decided to raise bonds upto Rs.5,000 crores in the first tranche. The proceeds of the bonds shall be on lent by HSFSL to respective SPVs to carry out the identified projects. The Funds will support investments strictly following the principles of Environmental, Social and Governance (ESG) Framework.
- 4. Finance Department, Government of Haryana is seeking willingness of NCRPB and suggest terms and conditions for partnering with the Government in the issue of SDG Bonds (for upto Rs. 5000 Crore) with State Government Guarantee and further lend the proceeds to HSFSL for the Haryana SDG Economic Recovery Fund.
- 5. The matter is examined in the NCRPB. Proposal of Govt of Haryana does not meet NCRPB mandate in vogue since NCRPB provides financial assistance directly to Projects of State Government or their Implementing Agencies. Board extends financial assistance on the project proposals based on the merits of the project proposal and their conformity with the Regional Plan/Functional Plans(s) as per mandate given in Section 8(e) and Section 22(2)(c).
- 6. However, vide letter dated 07.07.21 (copy enclosed) addressed to ACS, Finance, Govt. of Haryana, NCRPB has sought certain clarification / information for further examination in NCRPB and thereafter for concurrence of PSMG-I.

The matter is placed before PSMG-I for information and Guidance please.

Dear Six,

I would like to draw your kind attention towards your proposal regarding raising of SDG Economic Recovery Bonds to set-up Haryana SDG Economic Recovery Fund and willingness of NCRPB with terms and conditions vide letter no. 3/1/2021-SDG Bonds (2) dated 18:06:2021 (copy enclosed).

- In this regard, for considering the proposal, following requirements of NCRPB may please be clarified/confirmed:
 - (i) As per NCRPB Act, 1985 the project proposals of NCR Region and CMAs in conformity of Regional Plan/Functional Plans should be submitted by the State or its Implementing Agency for financial assistance. Thus, the identified projects under this special line of funding to be submitted by the State Government or its Implementing Agency along with Detailed Project Report (DPR) and Loan Drawal Schedule (with date) for consideration by PSMG-1.
 - State Government shall provide Sovereign Guarantee as Security for raising bonds in the domestic market.
 - (iii) Type of Security i.e. State Guarantee or Bank Guarantee (@133.33% of the loan amount) to be provided for disbursing financial assistance.
 - (iv) Since, this is a special line of funding, the interest rate on financial assistance shall be 0.5% over and above the coupon rate of bonds as spread to meet out the administrative and maintenance cost involved in raising of bonds.
 - (v) Applicability of Commitment Charges @ 0.05% per annum on non-drawal and delayed drawal of loan, after sanction as per instalment, as approved by the Board in its 39th meeting.

In view of the above, you are kindly requested to clarify on above mentioned points for further consideration in this office and PSMG-I for its concurrence.







Agenda Item No.7: Status Note on Assistance by Asian Development Bank (ADB) and KfW (German Development Bank) to NCRPB.

7.1 Asian Development Bank: ADB has approved a loan of US \$ 150 million to NCRPB as a Multi-Tranche Financing Facility for financing infrastructure projects in the National Capital Region (NCR) and its Counter Magnet Areas (CMAs). The loan agreement for the 1st tranche of US \$ 78 million was signed between ADB and NCRPB on 17.3.2011. Out of Tranche-1 loan amount of USD 78 million, USD 18.01 million has been cancelled. Board has already utilized the entire loan amount of USD 59.99 million (INR 352.06 crore) by the loan closing date of 31.12.2014 for tranche1. The rate of interest is based on 6 months Libor + Margin as may be determined by ADB based on their cost of funds of the relevant period payable half yearly. The repayment period is 25 years with 5 years moratorium for repayment of the principal amount. The commitment charges were payable up to December, 2014 on the undrawn loan amount @ 0.15% p.a.

7.1.2. **Reimbursement of Commitment Charges:** Two MMTC projects at Anand Vihar and Sarai Kale Khan have been dropped and the matter regarding reimbursement of commitment charges to the tune of Rs.69,95,613.81 up to 31.01.2013 being borne & paid by NCRPB to ADB on account of the two non-starter projects of the Transport Department, Govt. of NCT of Delhi have repeatedly been taken up. Inspite of repeated reminders & discussions in the 59th PSMG-I meeting held on 28.9.2020 and preceding PSMG-I meetings, the same are still to be paid by the Transport Department, GNCT Delhi.

7.1.2.2. Proposal is placed before the Group for information.

- 7.1.3. **Debt Service:** Board has been making regular payments of its dues to ADB. So far, Board has made payment of Rs. 40.84 cr. (\$ 6.01 million) to ADB on account of interest and commitment charges. Further, Board has repaid an amount of Rs. 48.93 cr. (\$7.06 mn) towards principal outstanding to ADB as on February, 2021. The total outstanding loan is USD 52.94 million (Rs. 393.61 Cr.) as on 30th June 2021.
- 7.1.3.1 ADB vide letter dated 2.12.2020 regarding Loan 2660-IND: National Capital Region Urban Infrastructure Financing Facility Project 1 submitted the proposal for Amendments to the Loan Agreement with respect to the Reference Rates Transition. The case for approval has been submitted to Ministry of Housing & Urban Affairs vide letter dated 27.1.2021.

7.1.3.2. Proposal is placed before the Group for information.

- KfW (German Development Bank): Loan agreements of Euro 100 million + Euro 1 million Grant for environment friendly schemes in the water supply, sewerage, drainage, solid waste management and urban transport Sectors to National Capital Region Planning Board were signed on dated 9.2.2012 & 30.3.2012 respectively. The repayment period is 15 years with a 5 years moratorium for repayment of the principal amount. The loan is at fixed rate of Interest @1.83% p.a. A total amount of Euro: 100 million (Rs. 745.99 Crores) has been claimed & disbursed by KfW to the Board. The commitment charges were payable @ 0.25% p.a. up to December, 2016 and subsequently @ 0.40% p.a. w.e.f. January 2017 to December, 2018 on the undrawn loan amount.
